WORKING COMMITTEE TO ADVISE THE GOVERNMENT ON THE CASE BEFORE THE INTERNATIONAL CRIMINAL COURT INVOLVING KENYAN CITIZENS

APPOINTMENT

IT IS notified for the general information of the public that following the ruling by the International Criminal Court Pre-Trial Chamber II Judges at the Hague on the 23rd January, 2012, regarding the case against the six Kenya post-election violence suspects and pursuant to the directions given by His Excellency the President, the Hon. Attorney-General has established a Working Committee to advise the Government of Kenya on the Case.

1. The Working Committee shall comprise of the following-

- 3. The terms of reference of the Working Committee are to-
 - (a) study and review the ruling of the International Criminal Court, Pre-Trial Chamber II-Situation in the Republic of Kenya: IN THE CASE OF THE PROSECUTOR vs WILLIAM SAMOEI RUTO, HENRY KIPRONO KOSGEY, & JOSHUA ARAP SANG' AND IN THE CASE OF THE PROSECUTOR vs FRANCIS KIRIMI MUTHAURA, UHURU MUIGAI KENYATTA & MOHAMED ALI;
 - (b) advise the Government of Kenya on the legal obligations arising under the Rome Statutes, the Constitution of Kenya, 2010, and the International Crimes Act, 2008, in respect of the confirmation of charges by the Pre-Trial Chamber II, in respect of WILLIAM SAMOEI RUTO, JOSHUA ARAP SANG' FRANCIS KIRIMI MUTHAURA, UHURU MUIGAI KENYATTA;
 - (c) advise the Government of Kenya on its rights as a State Party to the Rome Statute, the Constitution of Kenya, 2010, and the International Crimes Act, 2008, in light of the case THE PROSECUTOR vs WILLIAM SAMOEI RUTO & JOSHUA ARAP SANG' AND THE PROSECUTOR vs FRANCIS KIRIMI MUTHAURA & UHURU MUIGAI KENYATTA:
 - (d) advise the Government of Kenya on any legal measures that it ought to take arising out of the ruling of the Pre-Trial Chamber II, in respect of confirmation of charges against WILLIAM SAMOEI RUTO, JOSHUA ARAP SANG' FRANCIS KIRIMI MUTHAURA, UHURU MUIGAI KENYATTA;
 - (e) advise the Government of Kenya on any other matters related or incidental to the cases: THE PROSECUTOR vs WILLIAM SAMOEI RUTO, HENRY KIPRONO KOSGEY, & JOSHUA ARAP SANG' AND THE PROSECUTOR vs FRANCIS KIRIMI MUTHAURA, UHURU MUIGAI KENYATTA & MOHAMED ALI.
- The duration of the exercise shall be a period of thirty days, with effect from the 6th February, 2012.
- The Working Committee shall present its report to the Attorney-General at the expiry of the thirty days.
