DECLARATION OF PERSONS ELECTED AS MEMBERS OF THE COUNTY ASSEMBLY WARD REPRESENTATIVES

IN EXERCISE of the powers conferred by section 2 (1) (a), (b), (c) and 9 of the Sixth Schedule to the Constitution of Kenya, Article 88 (4), 177 (1), 193 (1) of the Constitution, section 4 of the Independent Electoral and Boundaries Commission Act, 2011, Sections 39 (1), (2) and (3), Section 25 (1), (2) and (3) of the Elections Act, 2011 Regulations 66 (1), (2), (3), and 87 (1) (b) (4) (b) of the Elections (General) Regulations, 2012 and pursuant to Gazette Notice No. 2928 of 2013 dated 1st March, 2013, the Independent Electoral and Boundaries Commission declares that the persons elected as members of the County Assembly Ward Representatives in the postponed election held on 18th March, 2013 and complied with the provisions of the Elections Act, 2011 and of the Constitution, are hereby listed in the Schedule to this notice.
