- (c) Establish the reasons for low enrolment in the County Youth Polytechnic.
- (d) Review the polytechnic curriculum to include more of agricultural content.
- (e) To establish the status of physical facilities and the human resource in Early Childhood Development Education, Primary, Secondary and Tertiary Education in Kakamega county, and the challenges therein.
- (f) To determine the causes of below par performance at primary and secondary level in terms of enrolments and learning outcomes and propose measures for improvement.
- (g) Evaluate performance indices at the ECD centres and Youth Polytechnics and propose mechanisms for enhanced enrolment and learning outcomes.
