TRIBUNAL TO INVESTIGATE THE CONDUCT OF MR. AHMEDNASIR ABDULLAH; REV. DR. SAMUEL KOBIA; PROF. CHRISTINE MANGO; MR. JUSTICE MOHAMED WASARME; MS. EMILY OMINDE; MS. FLORENCE MWANGANGI, MEMBERS OF THE JUDICIAL SERVICE COMMISSION

### **APPOINTMENT**

WHEREAS a petition for the removal from office of Mr. Ahmednasir Abdullahi, Rev. (Dr.) Samuel Kobia, Prof. Christine Mango; Mr. Justice Mohammed Warsame; Ms. Emily Ominde and Ms. Florence Mwangangi as members of the Judicial Service Commission, was presented to the National Assembly in accordance with the provisions of Article 251(2) of the Constitution on the 16th October, 2013;

AND WHEREAS, the National Assembly considered the petition in accordance with Article 251(3) of the Constitution and by a resolution passed on the 7th November, 2013, was satisfied that the petition discloses grounds under Article 251(1) of the Constitution for the removal of the said members of the Judicial Service Commission from holding office as such;

AND WHEREAS the petition was presented to me on the 14th November, 2013, in accordance with Article 251(3) of the Constitution,

NOW THEREFORE, in exercise of the powers conferred on me by Article 251(4) and (5) of the Constitution, I, Uhuru Kenyatta, President and Commander-in-Chief of the Kenya Defence Forces, appoint –

Hon. (Rtd.) Justice Aaron Gitonga Ringera to be the Chairperson; and  
Jennifer Shamallah  
Ambrose Otieno Weda  
Mutua Kilaka

to be members of a Tribunal to investigate the matter.

1. The mandate of the Tribunal shall be –

- (a) to investigate the alleged conduct of the said members of the Judicial Service Commission and determine whether it

discloses grounds for removal of any or all of them from office under Article 251 (1) of the Constitution;

- (b) to report on the facts and make its recommendations thereon to me expeditiously.

2. Pending the report of the Tribunal, the said members of the Judicial Service Commission stand suspended from exercising the functions of their office with immediate effect.

3. The Tribunal shall have all the powers necessary for the proper execution of its mandate, including the power to –

- (a) determine the times and venue for its meetings;  
(b) to regulate its own procedure.
