PARLIAMENTARY BY-ELECTIONS FOR NYARIBARI CHACHE MEMBER OF NATIONAL ASSMEBLY SCHEDULED TO BE HELD ON 30TH DECEMBER, 2013

IN EXERCISE of the powers conferred by Article 84, 85, 88(4), 101(4) of the Constitution of Kenya, Sections 13(3), 16, 22, 32, 38, 74 of the Elections Act, and Regulations 11 (4) and 12 (1), part III and V of the Elections (General) Regulations, the Independent Electoral and Boundaries Commission gives notice that:

- (a) Following the decision of the Court of Appeal in KISUMU CIVIL APPEAL. NO. 48 OF 2013 – CHRIS MUNGA NYAMARATANDI BICHAGE-vs-RICHARD NYAGAKA TONGI') delivered on 11th December, 2013 dismissing the said appeal and consequently discharging Stay Orders which had been granted in KISUMU CIVIL APPL NO 39 (UR 17) OF 2013 involving the same parties, the Commission shall conduct a By-Election for Member of the National Assembly for Nyaribari Chache Constituency.
- (b) The candidate(s) who were to deliver their nomination papers on Tuesday, 22nd November, 2013 shall present their papers to the said Returning officer on 16th December, 2013 between the hours of eight o'clock in the morning and four o'clock in the afternoon.
- (c) Disputes relating to or arising from decisions of the Returning Officer after nominations shall be determined within seven days of lodging the dispute(s) with the Commission.
- (d) Pursuant to the provisions of Regulation 57 (1) and (2) of the Elections (General) Regulations, 2012 every Political Party and every Independent Candidate at the by-election shall submit to the Commission names of the Chief Agents on or before 17th December, 2013.
- (e) The campaign period for purposes of the 30th December, 2013 By-Elections shall terminate on 28th December, 2013 at 6:00 p.m. being at least 24 hours preceding the election date.

- (f) The campaign time shall run from 7:00 a.m. to 6:00 p.m. during the campaign period.
- (g) The By-election will take place on the 30th December, 2013.

NOTES:

- All the other candidates who were cleared on 21st November, 2013 are not required to present their nomination papers afresh as they had successfully been cleared.
- The attention of candidates and persons subscribing nomination papers is drawn to the provisions of Part III and V of the Election (General) Regulations on the Parliamentary Elections (Subsidiary Legislation), First Schedule to the Leadership and Integrity Act, No. 19 of 2012 and Chapter Six of the Constitution of Kenya.
- 3. Every political party and every person who participates in the by- election shall subscribe to and observe the Electoral Code of Conduct set out in the Second Schedule to the Elections Act, 2011.
- In accordance with the provisions of Section 26 of the Elections Act, 2011 any candidate who intends to vie for the by-election should not participate in public fundraising.
