## 2. The terms of Reference of the Committee are to:

- (a) Develop the Terms of Reference for the Specific Offices established in the Inter-Governmental Relations Technical Committee.
- (b) Develop the criteria for recruitment of the specific positions.
- (c) Oversee the advertisement for the positions of the Inter-Governmental Relations Technical Committee.
- (d) Receive, evaluate, and generate a short-list of the applications

(e) Interview the shortlisted candidates.

(f) Undertake a due diligence on the selected candidates.

(g) Submit a final report with the recommended candidates for recruitment to the Summit.

## 3. Reporting

In the performance of its functions, the Committee shall be responsible to the Cabinet Secretary responsible for Intergovernmental Relations and the Chairperson of the Council of Governors.

## 4. Meetings

The committee shall—

(a) hold such number of meetings in such places and at such times as the Committee may consider necessary for the proper discharge of its functions; and

(b) regulate its own procedures.

## 5. Terms of office

The Committee shall remain in office for a period of 90 days from the day of their appointment or for such a period as the Cabinet Secretary may deem necessary.

**CHAPTER ONE: PREAMBLE****BACKGROUND**

Article 6(1) and the first schedule of the constitution of Kenya 2010 provides for the division of the national territory into counties. In view of the restructuring of the government from a centralized to a devolved system and the subsequent re-distribution of functions between the two levels of government, each county is in the process of implementing its functions and constitutional mandate as effectively as they could. This brief report is meant to show the status of implementation of the county public service activities as discharged by the County Public Service Board in accordance with part vii of legal notice number 17 of 2012 and the constitution of Kenya 2010.

**1.1 JUSTIFICATION FOR THE EXISTENCE AND EXERCISES OF THE CPSB****1.1.1 Establishment and composition of CPSB**

Section 56 of the County Government act 2012 provides for the establishment of a County Public Service Board while section 58 specifies composition of its membership and modalities of appointment to the board. In view of this articles, the board has certified requirement of the law by having a vice chair and the chairperson of opposite genders and having all its members appointed by the Governor and approved by the County Assembly on 29th of July 2013 as provided for in section 58 (1) (a) and 58 (1)(b). The chairman and members of the board were sworn into office on 14th of August 2013.

In respect to qualifications, all board members have certified requirements of the county government act of 2012 section 58 (3) (a), (b), (c) and (d). However, the board is operationalising its administrative functions through an acting secretary since a secretary to the board is yet to be recruited.

**1.1.2 Function and powers of CPSB**

Section 59 (1) of the county government act 2012 specifies the functions and powers of the county public service board as acting on behalf of the county government in undertaking the following;

1. Establishing and abolishing offices in county public service.
2. Appointing persons to hold or act in offices in county public service including in the board of cities and urban areas within the county and to confirm appointments.
3. Exercising disciplinary control over and remove, persons holding or acting in those offices as provided for by the law.
4. Prepare regular reports for submission to the county assembly on the execution of the functions of the board.
5. Promote in the county public service the values and principles referred to in article 10 and 232.
6. Evaluate and report to the county assembly on the extent to which the values and principles referred to article 10 and 232 are complied with in the county public service.
7. Facilitate the development of coherent, integrated human resource planning and budgeting for personnel emoluments in counties.
8. Advise the county government on human resource management/development.
9. Advise county government on implementation and monitoring of the national performance management system in the counties.
10. Make recommendations to the SRC on behalf of the county government on selected issues for county public service employees.

### 1.1.3 REPORTING MODALITIES IN THE CPSB

The justification for preparation and presentation of reports by the CPSB is detailed in section 59 (3) and 59 (5) of the county government act of 2012. Section 56 (6) of the same act clearly specifies the primary recipient of the report to be the county assembly and the timeline that must be adhered to for publication of the report in the county or Kenyan Gazette. In respect to the said legal notices;

**(a). The contents of the report shall provide details of;**

1. Number of persons appointed to the county public service.
2. Gender representation of appointees to the public service.
3. Status representation of appointees to the public service. That is in terms of disability status, minority and marginalized status and youth representation.

**(b). The timelines and modalities of presentation of the report should provide details of;**

1. Delivery of the report by December of each year to the county assembly.
2. Analysis of all decisions and steps taken by the board.
3. Specific recommendations that require to be implemented.
4. Specific decision on particulars of persons or public bodies that have violated the values and principles and actions taken or recommended against them.
5. Impediments witnessed in the promotions and values and principles of public service.
6. The programs that the board is undertaking or has planned to undertake to promote values and principles of article 10 and 232 of the constitution of Kenya 2010.

In view of the above listed provisions, the county public service board of Turkana in compliance with provisions of the law has prepared this report for the 6-month period between August 2013 and January 2014.

## CHAPTER TWO: REPORT OF EMPLOYMENT ACTIVITIES OF THE CPSB OF TURKANA

### Introduction

Pursuant to section 59 (5) and 62 (1), (2), (3) and (4), the status of employment in the county of Turkana for the six-months period from August 2013 to January 2014, is hereby summarized in the following sub headings; training and Human Resource Development report, public relations and communications report, Human Resource Audit Report and Recruitment and appointment reports.

### 2.1 Training and Human Resource Development Report

During the period under review, the board carried out capacity building and competencies developed by;

1. Availing training opportunities for staffs.
2. Group workshops and seminars

In general, the workshops and trainings facilitated acquisition of the necessary skills and knowledge for operationalising the mandate of the Turkana County Public Service Board in respect to the following;

1. Effective selection and recruitment of employees to the CPSB.
2. Legal compliance in undertaking CPSB activities.
3. Liaison and interrelationship with other institutions/stakeholders.
4. Effective management of classified information.
5. Implementation of the constitutional requirements in respect to ethical compliance, gender and regional representation.

### 2.2 PUBLIC RELATIONS AND COMMUNICATIONS REPORT

The public relations and communications unit is responsible for enhancing relations with the internal and external publics. The unit also manages communication between the commission and its various publics. The unit aims to cultivate a strong positive image of the CPSB. It is a unit that was created and subsequently inaugurated on 3<sup>rd</sup> December 2013 in respect to the need to strengthen operations of the board when handling media and publicity issues. The unit is expected to work closely with the secretary to the board to facilitate implementation of programs that will lead to the following;

- Timely delivery of reports of the board to the county assembly and any other authority that may require the same.
- Benchmarking of activities of the board with those of the Public Service Commission of Kenya and other Public service boards.
- Initiating public communication programs like radio education for sensitizing the local population on board activities and processes.
- Facilitate information accessibility and information sharing among other activities.

The justification behind the creation of a PR unit was informed by the provisions of article 35 of the constitution of Kenya 2010 and sections 93 to sections 101 of the county government act of 2012.

### 2.3 Human Resource Audit Report

The aim of this section is to provide information on the status of;

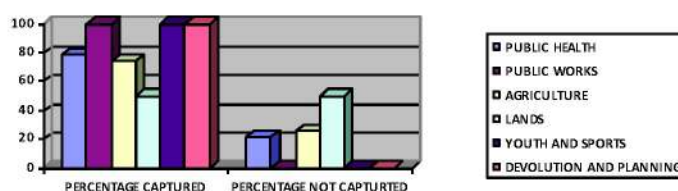
1. Audit of employees whose functions and remuneration was devolved to the county.
2. Audit of employees of the defunct Municipal and County Council of Turkana.

In respect to employees whose functions and remuneration was devolved to the county, preliminary findings indicates that 159 employees of six different Ministries/Departments were present during physical head count as well as in the county payroll. However, a total of 45 employees across the six ministries were not captured during physical head count.

The tables below, specifies the ministry and the percentage of devolved employees to the county government whose details are available in the county payroll and were present during physical head county against those who are in the county payroll but were not present during headcount as of January 2013.

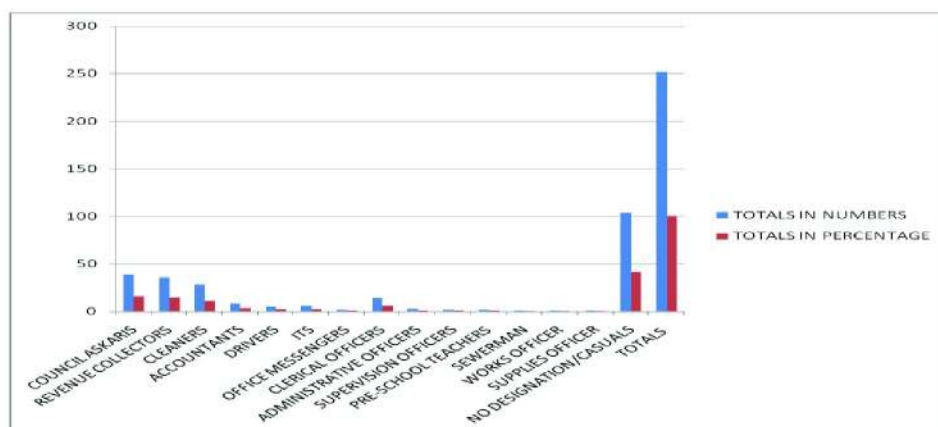

The graphical representation of the same indicates that on average, only 16% of all these cadres of workers had not been captured during the physical head count against 84% who had been captured. The total number of employees in this set was 204 where 159 were present while 45 were absent. The CPSB is working with the office of the county human resource manager to authenticate this report and will be giving the final word on it in due process. It is suggested that directors in each ministry/departments involved will be consulted in the preparation of the final audit report.



In respect to employees of the defunct Municipal and County Councils of Turkana, preliminary findings indicates that 148 employees had designations but 104 were either casuals or had no designations at all. The information has been summarized by the table below;

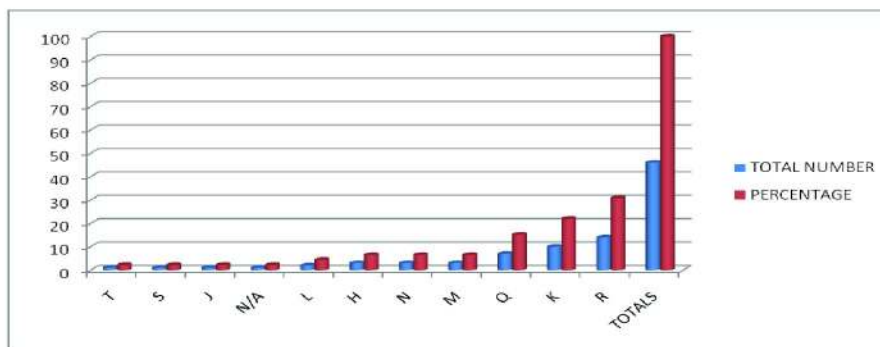

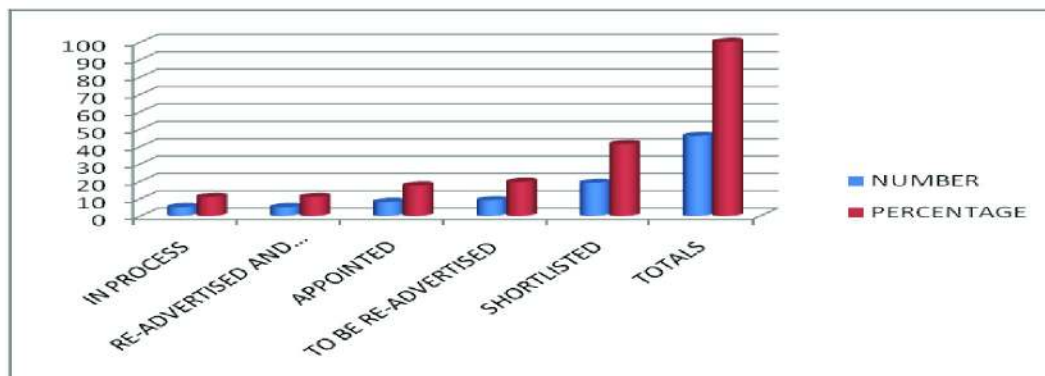

#### INVITATION OF PUBLIC COMMENTS

PURSUANT to regulation 21 of the Environmental Management and Co-ordination (Impact Assessment and Audit) Regulations, 2003, the National Environment Management Authority (NEMA) has received an Environmental Impact Assessment Study Report for the above proposed project.

The proponent (National Irrigation Board) has proposed to develop an irrigation project in the Lower Nzoia Basin which has been identified as having the potential to provide food security for the communities in the basin and beyond through irrigation water tapped from Nzoia River.

In Siaya County, the Lower Nzoia Irrigation Development Project (LNIDP) – Phase II covers the northern side of River Nzoia basin from Nzoia Bridge on Ugunja-Ukwala Road to Ruambwa and in Busia County it covers the area from Rumbwa to Nahasiongo River/Stream. The Lower Nzoia Irrigation Project Phase II is set to cover approximately 3,796 Ha of land in Siaya and Busia counties. The main beneficiaries of the project will be farmers in Bunyala East and Bundalangi North subwards of Bunyala Sub-County; and West Ugenya, Ukwala and North-West Ugenya subwards of Ugenya Sub-County.

Below is a summary of the anticipated impacts and proposed mitigation measures.

- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
