THE ENERGY ACT, 2006

(No. 12 of 2006)

THE DRAFT ENERGY (APPLIANCES' ENERGY
PERFORMANCE AND LABELLING) REGULATIONS, 2014

IN EXERCISE of the powers conferred by section 104 of the Energy Act, 2006, the Cabinet Secretary for Energy and Petroleum:

1. These Regulations may be cited as the Energy (Appliances' Energy Performance and Labeling) Regulations, 2014.
2. These Regulations shall apply to appliances covered in the First Schedule that are manufactured, imported, distributed or retailed for use in Kenya.
3. In these Regulations, unless the context otherwise requires –

“accredited laboratory” means a laboratory for testing appliances as per the Kenya Standards and approved by Kenya Accreditation Service;

“act” means the Energy Act No. 12 of 2006;

“approved” means authorization granted by the Commission;

“appliance” means an electrical equipment defined by the relevant Kenya Minimum Energy Performance Standards (MEPS);

“commission” has the meaning assigned to it under the Act;

“distributor” means a person who is involved in sourcing appliances from manufacturers or importers and selling to retailers and other end users;

“importer” means a person who is involved in sourcing appliances from other countries into Kenya for use or commercial purposes.

“label” means an illustration affixed on an appliance or printed on appliance packaging providing information on its energy performance based on the relevant Kenya Standards and determined by the Commission;

“manufacturer” means a person who makes appliances through a process involving raw materials, components and assemblies usually for commercial purposes;

“model” means a specific design of an appliance as assigned by the manufacturer;

"retailer" means a person that is involved in selling appliances to end users;

"standard" means the relevant Kenya Minimum Energy Performance Standards (MEPS);

"supplier" means manufacturer, manufacturers' local agent, importer or distributor involved in appliance model delivery chain.

"test certificate" means a document issued by an accredited laboratory after evaluation of energy performance of an appliance as per the Kenya Standard;

"testing" means an assessment of an appliance by an accredited laboratory to determine energy performance as per the relevant Minimum Energy Performance Standards (MEPS);

"registration certificate", a document given to a manufacturer, importer, distributor or retailer by the Commission to confirm that the appliances he/she is dealing with have met the Minimum Energy Performance Requirement.

4. (1) A person manufacturing, importing, or distributing any appliance in the First Schedule shall be required to have a sample of the appliance tested by an accredited laboratory and registered by the Commission.

(2) An appliance registered in 4(1) shall have an affixed energy label issued by the Commission.

(3) All appliances, listed in the First Schedule, shall be required to have a relevant label issued by the Commission.

5 (1) Any person who imports or manufactures an appliance for sale or use in Kenya shall register the model of the appliance with the Commission. (2) An appliance model shall not be registered in 5(1) unless tested and is in compliance with the relevant Kenya Standards, a test report and test certificate submitted to the Commission.

(3) Where an appliance model has already been registered, an applicant may not be required to submit another test report and certificate for it unless the applicant is the manufacturer.

(4) Application for registration shall be made as per the registration categories defined in the Second Schedule.

(5) A person applying for appliance registration shall—

- (a) Submit appliance model test report and certificate where applicable.
- (b) submit a duly completed application form as provided for in the Third Schedule
- (c) pay application fees as provided for in the Second Schedule

(6) Where a manufacturer has applied for registration of an appliance model and the registration certificate is valid; importer, distributors, and retailers shall not be required to apply for registration, but shall be required to label the appliance model.

(7) Where a registered appliance model sold to an end user does not meet the energy performance criteria as set out in the relevant Standard, the retailer and / or supplier shall pay a fine of one hundred thousand shillings.

(8) A person, whose appliance is registered, who fails to submit data to the Commission as set out in the Fourth Schedule on a yearly basis within six months after the end of the calendar year shall pay a fine of one hundred thousand shillings for each year or part thereof that the data is not submitted.

6 The labels applicable in these regulations are as provided for in the Fifth Schedule.

7 The Commission may exempt from these Regulations—

- (a) Importation of appliances for domestic use that do not meet the requirements of the relevant Standards by returning residents as provided for in the relevant Kenya Customs rules and regulations.

8 (1) The Commission or its agent may carry out inspection on suppliers' and retailers' premises, and appliances, in relation to the

manufacturing, importation, distribution or retailing of appliances in accordance with the relevant Standard and these regulations.

(2) The Commission shall order the person whose appliances are registered to re-test the appliance where it finds that a supplier or retailer has contravened the provisions of these Regulations or that a condition has arisen, which has the potential of contravening these Regulations.

(3) Where such re-test is ordered as 8(2), the person shall bear the associated costs and submit test report and certificate within the order period.

(4) The Commission may, at its own costs, re-test, inspect or re-inspect appliances where necessary.

(5) The Commission shall issue a non-compliance notice under regulations 8(1), 8(2) and 8(4) which shall state—

- (a) the specific provisions which have been or are likely to be contravened;
- (b) the measures which should be taken to rectify the contravention; and
- (c) the period within which the notice shall be complied with.

9 (1) The Commission may suspend or revoke any registration certificate of an appliance issued under these Regulations upon being satisfied that the person has contravened any of the terms and conditions of the registration or any provision of these regulations.

(2) Upon the suspension or revocation of a registration certificate under sub regulation 9(1), the Commission shall notify by written notice to such a person, which shall set out the reasons thereof and such notice may disqualify the appliance from holding a registration certificate for such period as the Commission deems fit.

(3) Where the Commission suspends or revokes the registration certificate of a supplier or retailer, it shall remove the name of the appliance from the register of registered appliances for the period set in these Regulations.

(4) The manufacturer, importer, distributor or retailer whose appliance registration certificate has been revoked has to recall from the market all appliances suspended within six months of the notice.

(5) A manufacturer, importer, distributor or retailer who fails to comply with 9(4) shall pay a fine of one million shillings for each subsequent six months that the appliances are not recalled.

(6) Every appliance registration certificate, unless it is suspended or revoked, shall remain in force until it expires and shall not be transferable.

10 Where, upon application, it is shown to the satisfaction of the Commission that an appliance registration certificate has been lost, destroyed or defaced; the Commission may issue a duplicate certificate.

11 (1) The Commission shall maintain a register of all appliance models registered under these Regulations.

(2) The register shall be available to the public for inspection.

12 (1) A registration certificate issued under these Regulations shall be valid until the next revision of the relevant Standard.

(2) A person shall be required to apply for a fresh registration upon revision of the relevant Kenya Standard.

(3) The revised relevant Standard and label shall be applicable to appliances—

- (a) Imported or manufactured one year after the revision
- (b) Retailed or distributed two years after the revision

13 Any person who by self, servant, or agent—

- (a) undertakes or carries out any manufacturing, importation, distribution or retailing of an appliance model without a valid registration certificate or label;

- (b) contravenes or fails to comply with any of the terms and conditions of registration under these Regulations or willfully gives false or misleading information relating to these Regulations;
- (c) submits or causes to be submitted to the Commission or its agent a test report and test certificate, where applicable, which the person knows or has reason to believe is false in any material particular therein;
- (d) contravenes or fails to comply with any of these Regulations or who fails to comply with any prohibition or order of the Commission under any of these Regulations;
- (e) denies, interferes and /or obstructs inspection of appliances by the Commission or its agents,
- (f) assists a person to contravene these Regulations;
- (g) commits an offence and shall be liable to a fine not exceeding one million shillings, or to imprisonment, on conviction, for at term not exceeding one year, or both.

13 (1) These regulations shall apply to all appliances, listed in the First Schedule, manufactured or imported one year after gazettment.

(2) These regulations shall apply to all appliances, listed in the First Schedule, distributed or retailed two years after gazettment.

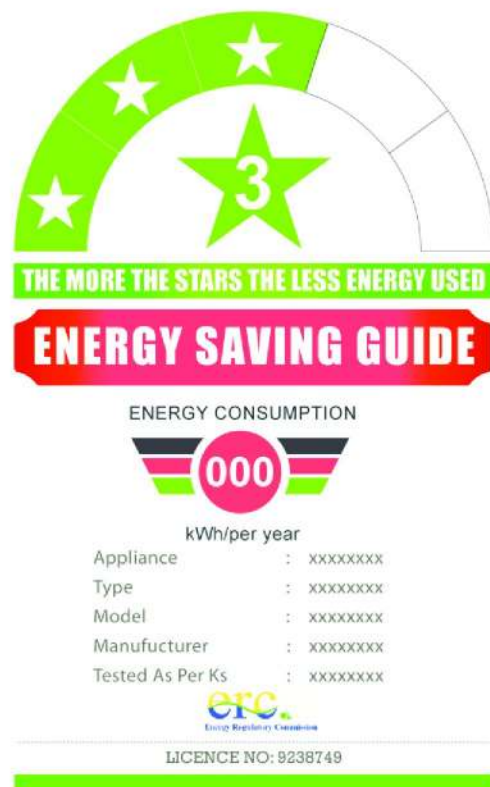

- (ii) must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.
