PARLIAMENTARY BY-ELECTION; MEMBER OF NATIONAL ASSEMBLY FOR OTHAYA CONSTITUENCY SCHEDULED TO BE HELD ON 29TH APRIL, 2014

IN EXERCISE of the powers conferred by Article 84, 85, 88 (4) and 101(4) of the Constitution of Kenya, Sections 13(3), 16, 22, 32, 38, 74 of the Elections Act, and Regulations 11 (4)-(5) and 12 (1), Part III, and VII of the Elections (General) Regulations, the Independent Electoral and Boundaries Commission ("the Commission") gives notice that:

(a) Following the decision in the Supreme Court of Kenya APPL. No. 12 of 2014—Mary Wambui Munene –vs- Peter Gichuki Kingara, the Independent Electoral and Boundaries Commission and James Mbai delivered on 24th April, 2014 an Order of Stay pending hearing and determination of the Appeal; the Commission shall not conduct a By-Election for Member of National Assembly for Othaya Constituency as earlier published.

(b) The Gazette Notice No. 1719 of 2014 is amended accordingly.
