INSTITUTIONAL FRAMEWORK FOR THE JOINT
NATIONAL AND COUNTY GOVERNMENTS CAPACITY
ASSESSMENT AND RATIONALISATION PROGRAMME OF
THE PUBLIC SERVICE

ESTABLISHMENT

IT IS notified for the general information of the public that the Cabinet Secretary for Devolution and Planning has, in furtherance of the decision of the Summit to implement a joint capacity assessment and rationalization programme for the public service at the national and county levels of government, established the institutional framework for the joint national and county governments programme.

INTER-GOVERNMENTAL STEERING COMMITTEE

1. There is established the Inter-Governmental Steering Committee.

2. The Inter-Governmental Steering Committee comprises of—

- (a) the Cabinet Secretary for Devolution and Planning;
- (b) the Cabinet Secretary for the National treasury;
- (c) the Cabinet Secretary for Labour, Social Security and Services;
- (d) the Chairperson of the Council of Governors;
- (e) the Chairperson of the Public Service Commission;
- (f) the Chairperson of the Salaries and Remuneration Commission;
- (g) the Chairperson of the Commission for Revenue Allocation;
- (h) the Chairperson of the Commission for the Implementation of the Constitution;
- (i) the Chairperson of the Transition Authority;
- (j) the Attorney-General; and
- (k) the Chairperson of the Human Resource and Social welfare committee of the Council of Governors.

3. The Cabinet Secretary for Devolution and Planning and the Chairperson of the Council of Governors shall be the co-chairpersons of the Inter-Governmental Steering Committee.

4. The functions of the Inter-Governmental Steering Committee are—

- (a) to provide vision, leadership and policy direction for the capacity assessment and rationalisation programme;
- (b) to oversee the implementation of the capacity assessment and rationalisation programme; and
- (c) to report on the implementation of the capacity assessment and rationalisation programme to the Summit established under section 7 of the Intergovernmental Relations Act, 2012.

5. The Inter-Governmental Steering Committee may co-opt other members as may be required to better perform its functions.

6. The Inter-Governmental Steering Committee shall meet at least two times in a year at such times and places as may be appropriate.

INTER-AGENCY TECHNICAL COMMITTEE

7. There is established the Inter-Agency Technical Committee.

8. The Inter-Agency Technical Committee comprises of—

- (a) the Principal Secretary in the Ministry of Devolution and Planning;
- (b) the Principal Secretary in the National Treasury;
- (c) the Principal Secretary in the Ministry of Labour, Social Security and Services;
- (d) the Secretary to the Public Service Commission;
- (e) the Pensions Secretary in the National Treasury;
- (f) the Secretary to the Salaries and Remuneration Commission;

(g) the Solicitor-General;

(h) the Principle Administrative Secretary in the Ministry of Planning and Devolution in charge of the Directorate of Public Service Management;

(i) a representative of the Commission for the Implementation of the Constitution;

(j) a representative of the Transition Authority;

(k) a representative of the Council of Governors;

(l) a representative of county public service boards;

(m) a representative of county assembly service boards;

(n) a representative of the Kenya Institute of Public Policy Research and Analysis;

(o) a representative of the Federation of Public Service Trade Unions (PUSETU);

(p) a representative of the Union of Kenya Civil Servants (UKCS);

(q) a representative of the County Government Workers Union;

(r) two persons representing the private sector in Kenya appointed by the Cabinet Secretary for Devolution and Planning; and

(s) three persons with expertise and experience in public sector restructuring appointed by the Cabinet Secretary for Devolution and Planning.

9. The functions of the Inter-Agency Technical Committee are—

(a) to provide overall management of the capacity assessment and rationalisation programme;

(b) to implement the policy directions of the Inter-Governmental Steering Committee;

(c) to provide technical assistance to ministries, departments and county governments;

(d) to facilitate consultation with ministries, departments, county governments and administrators of schemes of service for public officers affected by the capacity assessment and rationalisation programme;

(e) to approve activities for the implementation of the capacity assessment and rationalisation programme;

(f) to monitor and evaluate the capacity assessment and rationalisation programme;

(g) to oversee preparation of the framework for the capacity assessment and rationalisation programme which includes—

(i) policy guidelines;

(ii) principles of capacity assessment and rationalisation;

(iii) criteria for capacity assessment and rationalisation;

(iv) appeal mechanisms;

(v) institutional arrangements for the implementation of the framework for the capacity assessment and rationalisation programme; and

(vi) monitoring and evaluation strategies;

(h) to develop a communications strategy for the capacity assessment and rationalisation programme;

(i) to develop training and sensitisation materials for the affected public officers;

(j) to develop an implementation plan for the capacity assessment and rationalisation programme;

(k) oversee the appointment of a lead consultant and supervise the lead consultant in the execution of that lead consultant's duties; and

(l) mainstream gender, youth and persons with disability concerns in the implementation of the capacity assessment and rationalisation programme.

10. The Inter-Agency Technical Committee shall—

- (a) hold meetings as often as is necessary for the discharge of its functions and in any case, at least once in a month, at places and times that it shall consider proper;
- (b) regulate its own procedure; and
- (c) co-opt other persons as shall be required by the Inter-Agency Technical Committee for the performance of its functions.

11. The Principal Administrative Secretary in the Ministry of Devolution and Planning, Directorate of Public Service Management and the representative of the Transition Authority shall be the co-chairpersons of the Inter-Agency Technical Committee.

INTER-AGENCY SECRETARIAT

12. There is established an Inter-Agency Secretariat which comprises of representatives from—

- (a) the Ministry of Devolution and Planning;
- (b) the Ministry of Labour, Social Security and Services;
- (c) the National Treasury;
- (d) the Pensions Department of the National Treasury;
- (e) the Public Service Commission;
- (f) the Office of the Attorney-General and Department of Justice;
- (g) the Transition Authority;
- (h) the Salaries and Remuneration Commission; and
- (i) the Council of Governors.

13. The functions of the Inter-Agency Secretariat are—

- (a) to co-ordinate the implementation of the decisions and directions of the Inter-Agency Technical Committee;
- (b) to provide technical assistance and support to the rationalisation technical committees of ministries and departments and the rationalisation steering and technical committees of county governments;
- (c) to facilitate the work of the lead consultant;
- (d) to co-ordinate and facilitate the sensitisation and training activities;
- (e) to receive and analyse progress reports from the lead consultant;
- (f) to report to the Inter-Agency Technical Committee on the work of the lead consultant;
- (g) to ensure compliance with the guidelines and;
- (h) to monitor and evaluate the capacity assessment and rationalisation programme.

14. The Inter-Agency Secretariat shall—

- (a) hold meetings as often as is necessary for the discharge of its functions;
- (b) regulate its own procedure; and
- (c) co-opt other persons as shall be required for the Inter-Agency Secretariat for the performance of its functions.

15. The Inter-Agency Secretariat shall engage such number of experts as it may deem necessary for the performance of its functions.

MINISTERIAL/DEPARTMENTAL RATIONALISATION TECHNICAL COMMITTEES

16. Each ministry or department shall establish a rationalisation technical committee.

17. Each rationalisation technical committee shall be responsible to the Inter-Agency Technical Committee for the overall implementation of the capacity assessment and rationalisation programme in the ministry or department and as such shall—

- (a) undertake institutional review of the Ministry/Department;
- (b) Assess skills and competencies required including determining optimal staffing;
- (c) establish existing human resource capacity in the Ministry/Department in terms of numbers and skills;

(d) identify staff eligible for re-deployment or transfer or separation;

(e) sensitise and train all staff affected by the programme;

(f) prepare reports to the Inter-agency Technical Committee; and

(g) generally implement the Programme in their respective Ministry/Department.

18. Each Rationalisation Technical Committee comprises of—

- (a) the Principal Secretary or the Authorised Officer, as the case may be, who shall be its chairperson;
- (b) the head of the human resource department, who shall be its secretary;
- (c) heads of department;
- (d) the head of the planning unit;
- (e) the head of the finance unit;
- (f) the head of the accounting unit;
- (g) a representative of the Public Service Commission;
- (h) a representative of the Directorate of Public Service Management of the Ministry of Devolution and Planning; and
- (i) the lead consultant.

19. A Rationalisation Technical Committee shall—

- (a) hold meetings as often as is necessary for the discharge of its functions and in any case, at least once in a month, at places and times that it shall consider proper;
- (b) regulate its own procedure; and
- (c) co-opt other persons as shall be required by the Technical Committee for the performance of its functions.

COUNTY RATIONALIZATION STEERING COMMITTEES

20. Each county government shall establish a County Rationalisation Steering Committee to be chaired by the respective Governor and comprising of the following—

- (a) Executive Committee Members;
- (b) Chairperson of the County Public Service Board;
- (c) Chairperson County Assembly Service Board;
- (d) Union Representative;
- (e) County Commissioner;
- (f) Transition Authority County Coordinator;
- (g) Representative, Ministry of Labour;
- (h) County Attorney; and
- (i) County Secretary, who will be Secretary to the Committee.

21. The functions of the County Rationalization Steering Committees are to—

- (a) provide vision, leadership and policy direction for the capacity assessment and rationalisation programme in the county;
- (b) oversee the implementation of the capacity assessment and rationalisation programme in the county;
- (c) work in consultation with Inter-agency Technical Committee and prepare periodical reports to the Inter-Agency Technical Committee;
- (d) approve and implement sensitization and training programmes; and
- (e) verify the lists of the staff identified for re-deployment, transfer or separation, if any.

22. The County Rationalization Steering Committee shall—

- (a) hold meetings as often as is necessary for the discharge of its functions and in any case, at least once in a month, at places and times that it shall consider proper;

- (b) regulate its own procedure; and
- (c) co-opt other persons as shall be required by the County Rationalization Steering Committee for the performance of its functions.

COUNTY RATIONALISATION TECHNICAL TEAM

23. Each county government shall establish a Rationalisation Technical Team which shall be chaired by the member of the relevant county executive committee responsible for matters relating to the county public service.

24. Each Rationalisation Technical Team shall also comprise of—

- (a) the chief officers of the relevant county departments;
- (b) the Secretary to the relevant county public service board;
- (c) the Secretary to the relevant county assembly service board;
- (d) the relevant county co-ordinator of the Transition Authority;
- (e) the relevant county commissioner;
- (f) a representative of the lead consultant; and
- (g) the relevant county secretary who shall be the Secretary to the Committee.

25. Each Rationalisation Technical Team shall—

- (a) undertake an institutional review of the county public service;
- (b) assess the skills and competencies required in the county government;
- (c) determine the optimal staffing for the county government;
- (d) establish the existing human resource capacity of the county government;
- (e) identify the public officers eligible for redeployment, transfer or separation;
- (f) sensitise and train the public officers affected by the capacity assessment and rationalisation programme;
- (g) facilitate the lead consultant at the county level;
- (h) prepare reports for consideration by the Inter-Agency Technical Committee on the capacity assessment and rationalisation programme; and
- (i) implement the capacity assessment and rationalisation programme in the county.

26. A Rationalisation Technical Team shall—

- (a) hold at least two meetings in a year at places and times that it shall consider proper;
- (b) regulate its own procedure; and
- (c) co-opt other persons as shall be required by the Technical Team for the performance of its functions.

IT IS notified for public information that I, Evans Odhiambo
Kidero, the Governor of the Nairobi City County, have appointed a

- (e) Advise on the development and implementation of appropriate
integrated solid waste management plan in order to enable
community participation and provide alternative waste
collection points far from the riparian.
- (f) Advise on the sustainable economic activities and settlements
in order to secure the riparian reserve and where necessary the
relocation of such activities and settlements in order to allow
for rehabilitation.
- (g) Develop and recommend to the county government a master
plan for economic, aesthetic, recreational and social utilization
of riparian zone and advise on the development ventures under
the master plan.
- (h) Conduct public awareness campaigns in order to enhance
public participation and ownership and to assess and establish
potential social and economic impacts of interventions.

3. Powers and Mode of Work

**IMPORTANT NOTICE TO SUBSCRIBERS TO
THE KENYA GAZETTE**

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette*, *Supplement*, etc.:

- (1) *The Kenya Gazette* contains Notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government. Because of this, they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the Notice is, each page being numbered and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
