- Designing transmission line route close to existing roads.
- Rehabilitate temporary access roads after completion of works.
- Minimize the number of new roads required.
- Locate the campsite in such a way that they can have residual values like turning them into schools and other public facilities.

Soil erosion

- Restrict use of heavy machinery and vehicles to designated work areas.
- Install soil protection works in areas sensitive to erosion prior to undertaking construction.
