 - Nairobi International Financial Centre,
 - to direct the Capital Markets Authority Board to appoint a taskforce, working groups and relevant subcommittees to facilitate the execution of the Master Plan;
 - to direct consultations with relevant government ministries and departments, regulatory agencies, capital markets experts, professional bodies, academics, and other stakeholders for the purposes of executing the Master Plan;
 - to provide policy direction on the execution of the Capital Markets Master Plan,
- The steering committee shall regulate its own procedure;
- The Secretariat of the steering committee shall be housed at the offices of the Capital Markets Authority, P.O. Box 78800-00200, Nairobi.
- The term of office of the steering committee shall be five (5) years renewable with effect from 1st January, 2015.
