Statutory Mandate and Functions of the National Council for Persons With Disabilities

The National Council for Persons with Disabilities is a State Corporation established by the Persons with Disabilities Act No. 14 of 2003 on 31st December, 2003. The Council was operationalized by Legal Notice Number 64 of 16th June, 2004.

The council is managed by a board of non-executive directors who are responsible for strategic policy formulation and direction and a Secretariat headed by the Chief Executive Officer.

The council is a high level inclusive policy, legislative, regulatory, implementing and programming oversight agency under the Ministry of Labour Social Security and Services.

The functions of the council include, to:

1. Promote, protect and uphold the rights, habilitation and rehabilitation of Persons with Disabilities within their Communities and the society.
2. Co-operate with the national government during national census and register persons with disabilities on a continuous basis to ensure that accurate figures of persons with disabilities are obtained in the Country for purposes of planning, development and service delivery.
3. Develop and Implement inclusive policies, legislations, regulations, and programmes on education, employment, health, accessibility, transport, sports and recreation, communication culture, and in all other aspects of social-economic life on the rights of persons with different categories of disabilities.
4. Conduct accessibility audits and usability of built environment.
5. Issue appropriate adjustment orders to owners of public and private buildings, services or amenities to secure and ensure access by persons with disabilities to the premises, services or amenities concerned.
6. Achieve equalization of opportunities for persons with disabilities and prevent discrimination against them.
7. Register institutions, associations, places and disabled persons organizations, including those that are controlled and managed by government, that provide services for the rehabilitation and welfare of persons with disabilities.
8. Advise on the provisions of any international treaty or agreement relating to the welfare or rehabilitation of persons with disabilities and the benefits of such treaty or agreement to Kenya.
9. Disability mainstreaming of public and private institutions.

10. Provide assistive devices, implements, sunscreen lotions, assistant to students with disabilities in the form of scholarships, loan programmes, fee subsidies and other similar forms of assistance in both public and private institutions.
11. Support vulnerable households caring for persons with severe disabilities who are duly registered with the council.
12. Enhance awareness raising on persons with disabilities and activities of the council.
13. Process in consultation with Kenya Revenue Authority income tax and any other levies exemptions on income, materials, articles and equipment, including motor vehicles and any government levies which would in any way increase costs to the disadvantage of persons with disabilities.
14. Engage or make other arrangements with any other person to carry out research on, or supply information on any matter relating to the welfare and habilitation and rehabilitation of persons with disabilities.

In order to effectively implement the provisions of the persons with disabilities Act, and give greater effect to the Constitution, 2010, the United Nations Convention on the rights of persons with disabilities, the council implements the following pieces of subsidiary legislations and standards:

- (a) The Persons with Disabilities (Access to Employment, Services and Facilities) Regulations, 2009.
- (b) The Persons with Disabilities (Cost Care, Support and Maintenance) Regulations, 2009.
- (c) The Persons with Disabilities (Registration) Regulations, 2009.
- (d) The Persons with Disabilities (Income Tax Deductions and Exemptions) Order, 2010.
- (e) The Persons with Disabilities (National Development Fund for Persons with Disabilities) (Conduct of Business and Affairs of the Board of Trustees) Regulations, 2009.
- (f) The Kenyan Standard, KS ISO 21542: "Building Construction- Accessibility and Usability of built environment". The standard provides building users, policy makers and legislators with requirements and recommendations to create a sustainable built environment which is accessible.

The council's vision, mission and values

The council is committed to upholding the following vision, mission and core values for its operations.

Vision

An institution of excellence responsive to disability human rights protection and mainstreaming in development.

Mission

To mainstream disability issues in all aspects of social-cultural, economic and political development.

Core values

Inclusivity, social justice, human dignity, equality, equity, integrity, transparency, accountability and good governance in implementing the Persons with Disabilities Act and other laws on disability.

PUBLIC NOTICE

Under sections 21, 22, 23, 24 and 26 of the persons with disabilities act no. 14 of 2003 chapter 133 laws of Kenya.

Under sections 21, 22, 23, 24 and 26 of the Act, there is a legal duty on proprietors/owners of public and private buildings of private nature, built environment, operators of public vehicles and providers of any services or amenities ordinarily provided to members of the general to adjust the same to accommodate various categories of persons with disabilities.

Pursuant to the said sections of the Act, the grace period upon which such proprietors/owners of public and private buildings of private nature, built environment, operators of public vehicles and providers of any services or amenities ordinarily provided to members of the general public were required by law to have adjusted their built

environment, services or amenities and fully complied with the Act lapsed in December, 2014.

SECTION 26 OF THE ACT

Offences on adjustment order and discrimination

FURTHER, failure to make such public and private buildings of private nature, built environment, operators of public vehicles and providers of any services or amenities ordinarily provided to members of the public disability compliant amounts to commission of offence(s) and discrimination targeting persons with disabilities in terms of section 26 of the Act.

Forty Five (45) Days Compliance Notice

It is in view of the above that the Council now requires proprietors/owners of public and private buildings of private nature, built environment, operators of public vehicles and providers of any services or amenities ordinarily provided to members of the general public to submit to the council within forty five (45) days from the date of this notice, their complete and comprehensive adjusted/re-adjusted built environment plans that allow persons with disabilities to carry out their duties without being at a disadvantaged position compared to persons without disabilities.

Further take notice that failure or refusal to comply with this notice and sections 21, 22, 23, 24 and 26 of the Act, shall be a proper legal basis for the Council to issue and confirm appropriate adjustment orders against the proprietors/owners of public and private buildings of private nature, built environment, operators of public vehicles and providers of any services or amenities ordinarily provided to members of the general public.

PART I—PRELIMINARY

- 1.1 Title— on the Indexing of Students.
- 1.2 Definitions—used in these Guidelines are as defined in the Constitution and the Health Officers (Training, Registration and Licensing) Act, 2013 except otherwise specified. Other terms used in these Guidelines shall be taken to have the meaning assigned to them hereunder:
 - 1.2.1 “accreditation” means formal recognition by Council of a training institution as compliant with the set minimum standards and capable to offer a course in Environmental Health;
 - 1.2.2 “accredited training institution” means any training institution formally recognized by Public Health Officers and Technicians Council as compliant with the set minimum standards and capable to offer a course in Environmental Health;
 - 1.2.3 “Council” means the Public Health Officers and Technicians Council as established under the Public Health Officers (Training, Registration and Licensing) Act, 2013 ;
 - 1.2.4 “eligible student” means a student applicant who meets the minimum requirements for indexing as prescribed by the Public Health Officers and Technicians Council;

- 1.2.5 “indexing” means the registration of students pursuing a course in Environmental Health by assigning them unique identifiers to facilitate the tracking of registered students during and after completion of training; and
- 1.2.6 “registration” means the act or process of entering information about an eligible professional into the Public Health Officers and Technicians Council’s system of records and the subsequent issuance of a certificate at a prescribed fee.
- 1.3 Acronyms —The used in these shall be taken to refer to the respective term as hereunder-
 - 1.3.1 “APHOK” means Association of Public Health Officers (Kenya).
 - 1.3.2 “B.ScEVH” means Bachelor of Science - Environmental Health.

 - 1.3.4 “CEO” means Chief Executive Officer
 - 1.3.5 “CUE” means Commission for University Education
 - 1.3.6 “KACE” means Kenya Advanced Certificate of Education
 - 1.3.7 “KCE” means Kenya Certificate of Education
 - 1.3.8 “KCSE” means Kenya Certificate of Secondary Education
 - 1.3.9 “KEMRI” means Kenya Medical Research Institute
 - 1.3.10 “KHWP” means Kenya Health Workforce Project
 - 1.3.11 “KMTTC” means Kenya Medical Training College
 - 1.3.12 “KNEC” means Kenya National Examinations Council

PART II —ROLE AND MANDATE OF PUBLIC HEALTH OFFICERS TECHNICIANS COUNCIL

2.1 Purpose

The purpose of the Council is:

- (a) to exercise general supervision and control over the training, practice and employment of public health officers and technicians in Kenya and to advise the government in all aspects thereof;
- (b) to regulate and maintain standards of public health training and practice.

PART III —INDEXING

3.1 Object and purpose of Indexing.

The object and purpose of the indexing is:

- (a) to establish and maintain a database of students pursuing Environmental Health programs at certificate, diploma and degree levels in accredited training institutions;
- (b) provide data on the students enrolled in training institutions to facilitate forecasting for both training and professional needs within and outside Kenya;
- (c) to provide a link between the learners, accredited training institutions and the Council; and
- (d) provide data for forecasting, manpower planning, employment and deployment to the public health labor market.

3.2 Academic Qualifications for Indexing.

- 3.2.1. A student seeking to pursue a career in Environmental Health shall do so in an accredited training institution.
- 3.2.2 A shall be indexed upon meeting the minimum requirements set out in the ’s curriculum.
- 3.2.3 The shall results of a bridging course conducted by the National Examinations Council other institutions whose accreditation it recognises.

3.2.4 An equivalent qualification from an alternative system of education and grading shall be authenticated by the in liaison with Kenya National Examination Council and the Commission for University Education other competent authorities.

3.2.5 A person shall be eligible to apply for a certificate course in Environmental Health if such person –

- (a) holds a Kenya Certificate of Secondary Education aggregate of C-minus its equivalent as ascertained by the Ministry of Education in addition to other requirements as set by the Health Officers and Technicians Council;
- (b) has grade of C-minus in the cluster subjects –
 - (i) English and Kiswahili; and
 - (ii) Biology or Biological Sciences or Physical Sciences; and
- (c) has a grade of D-plus any of the following subjects–
 - (i) Physics;
 - (ii) Chemistry;
 - (iii) Mathematics;
 - (iv) Home Science;
 - (v) Agriculture; or
 - (vi) General Science.

3.2.6 A person shall be eligible to apply for a diploma course in Environmental Health if such person –

- (a) holds a Kenya Certificate of Secondary Education aggregate of C-plus its equivalent as ascertained by the Ministry of Education in addition to other requirements as set by the Health Officers and Technicians Council;
- (b) has grade of C-plus in the cluster subjects –
 - (i) English and Kiswahili;
 - (ii) Biology or Biological; and
- (c) has a grade of C-minus mathematics and any of the following subjects–
 - (i) Physics;
 - (ii) Chemistry; or
 - (iii) Physical Sciences.

3.2.7 (1) A person shall be eligible to apply for a of Science degree course in Environmental Health if such person –

- (a) holds a Kenya Certificate of Secondary Education aggregate of C-plus its equivalent as ascertained by the Ministry of Education in addition to other requirements as set by the Health Officers and Technicians Council; and
- (b) has grade of C-plus in the cluster subjects of –
 - (i) Biology and Biological;
 - (ii) Chemistry and physical sciences;
 - (iii) Mathematics and Physics; or
 - (iv) English and Kiswahili; or
- (c) holds Diploma in Environmental Health Sciences, has grade of C-minus

3.2.8 Notwithstanding guideline (1), a person shall be eligible to apply for a Bachelor of Science degree course in Environmental Health if such person in Environmental Health Sciences –

- (a) a Kenya Certificate of Secondary Education aggregate grade of C- plain a grade of C-plain
 - (i) Biology, Chemistry and Physics; or
 - (ii) Mathematics and English or Kiswahili; or
- (b) for A-level certificate, a Advanced Certificate of Education of two and one subsidiary a Science combination, one of which must be in Biology.

PART IV—IMPLEMENTATION OF INDEXING

4.1 Functions of the Council in indexing

The functions of the Council in indexing shall be to implement indexing process and in particular, the Council shall:

- (a) approve the indexing policy;

- (b) approve indexing standards; and
- (c) appoint members of the Indexing Secretariat.

4.2 Functions of the Training Committee in indexing

The functions of the Training Committee in indexing shall be steering:

- (a) the development of indexing policies for Council's approval;
- (b) the development of indexing standards for Council's approval; and
- (c) the evaluation of training institutions for indexing purposes

4.3 Functions of the Indexing Secretariat in indexing

The functions of the Indexing Secretariat in indexing shall be to implement the indexing process consultation with the Council, and in particular, the Indexing Secretariat shall:

- (a) in liaison with the training committee, conduct evaluation of training institutions for indexing purposes;
- (b) evaluating eligible students for indexing purposes and correspond with the institutions;
- (c) receive, review and process duly completed documents for indexing purposes;
- (d) grant index numbers to eligible students and institutions;
- (e) provide feedback to training institutions on the status of indexing applications; and
- (f) safely keep, maintain and update records of indexed students and institutions

4.4 Functions of the Training Institutions in indexing

The functions of Training Institutions in indexing shall be:

- (a) to avail the list of students eligible for indexing to the Council;
- (b) to facilitate the payments or remittance of student indexing fees to the Council;
- (c) to provide feedback to the Council on –
 - (i) the status of indexed students enrolled in the institution; and
 - (ii) the details of indexed students who successfully complete studies in each academic year.

4.5 The documents required for Indexing

4.5.1 The documents required for indexing shall be by each applicant, through their accredited training, and consist of:

- (a) duly filled indexing application form attached with cover letter from accredited training institution.
- (b) two recent Passport size photos.
- (c) a certified copies of relevant academic certificates.
- (d) a certified copy of national identity card or passport.
- (e) a certified copy of student's identification card.
- (f) a certified copy of valid passport or relevant immigration documents for foreign students.
- (g) an official payment receipt

4.5.2 A certified copy of a document shall bear an authorized signature and stamp of the institution

4.6 Indexing Application Procedure

Where a person applies for indexing by the Council:

- (a) the application shall be made to the Indexing Secretariat through the applicant's training institution and
 - (i) in the prescribed format;
 - (ii) with the requisite certified copies of documents which bear an signature the training institution; and
 - (iii) upon payment of the prescribed application fee;
- (b) the Council shall acknowledge receipt of the indexing application documents from the training institution;
- (c) the Secretariat shall validate the application documents and submit the verdict to the Registration Committee;
- (d) the Council Registrar shall process the indexing applications as per the SOPs and periodically report to the Registration Committee;

- (e) the allocated Index Numbers shall be dispatched to the applicants, through the training institution

4.7 Approval of Indexing Process.

Once the indexing documents have been verified and validated by the Registration Committee, the approval process shall be effected as hereunder:

- (a) each qualified applicant shall be assigned a unique Index Number;
- (b) individual files shall be opened for each of the qualified applicants;
- (c) the Registration Committee shall approve the application based on the documents provided by each applicant;
- (d) the Secretariat shall process a summary report of the indexing process; and
- (e) the summary report shall be submitted to the Council for ratification and final approval.

4.8 Indexing Package.

4.8.1 An applicant who has been indexed by the Council shall receive an indexing package within 14 days following the completion of indexing process.

4.8.2 The indexing package shall contain:

- (a) an indexing card.
- (b) a Council prospectus.
- (c) the Code of conduct and ethics for PHOs/PHTs.
- (d) the Core Curriculum.
- (e) the PHOTC Act.
- (f) an Individual Student Training File.

4.9 Records and Archiving of Indexing Documents.

The Council shall maintain records and a database of the documents of each applicant in an easily retrievable manner and in particular, the Council shall keep records of:

- (a) each certified copy of documents required for indexing;
- (b) copies of each duly filled indexing forms;
- (c) copies of all correspondence between the Secretariat and applicants' training institution regarding the indexing process;
- (d) copies of Final Approval Reports for indexing.
- (e) copies of the minutes of meetings of the Registration Committee on indexing;
- (f) the Register of indexed students;
- (g) copies of payment receipts;
- (h) a list of accredited institutions;
- (i) copies of the Approved Core Curriculum; and
- (j) copies of Professional Code of Conduct for public health officers and technicians.

4.10 Indexing complaints and dispute resolution.

4.10.1 A complaint on indexing shall be directed to Council through the respective training institutions.

4.10.2 Where an indexing request has been rejected by the Council, the decision shall be communicated in writing to the applicant through the training institution.

4.11 Review of Indexing Guidelines.

4.11.1 The Secretariat and the Registration Committee shall be responsible for the review of these indexing guidelines.

4.11.2 Guidelines shall be reviewed every four years or as need arises.

PART I—PRELIMINARY

1.1 Title—on the Training and Accreditation Standards of Environmental Health Training Institutions.

1.2 Definitions—used in these Guidelines are as defined in the Constitution and the Health Officers (Training, Registration and Licensing) Act, 2013 except otherwise specified. Other terms used in these Guidelines shall be taken to have the meaning assigned to them hereunder:

1.2.1 “accreditation” means formal recognition by Council of a training institution as compliant with the set minimum standards and capable to offer a course in Environmental Health;

1.2.2 “Council” means the Public Health Officers and Technicians Council as established under the Public Health Officers (Training, Registration and Licensing) Act, 2013 ;

1.2.3 “placement site” means a designated facility or institution that is approved and accredited by the Council as a training center for students;

1.2.4 “practicum” means a prescribed period of study which involves a supervised practical application of previously studied theoretical knowledge designed for the preparation of students undertaking Environmental Health training;

1.2.5 “standard” means a desired level of quality or excellence that is accepted as the norm, or by which actual attainments are judged; and

1.2.6 “training institution” means An Environmental Health training institution.

1.3 Acronyms —The used in these shall be taken to refer to the respective term as hereunder —

1.3.1 “B.Sc” means Bachelor of Science.

1.3.2 “Dip” means Diploma.

1.3.3 “EH” means Environmental Health.

1.3.4 “EMCA” means Environmental Management and Coordination Act, 2009.

1.3.5 “FTSE” means Full Time Student Equivalent.

1.3.6 “HND” Higher National Diploma.

1.3.7 “KEMRI” means Kenya Medical Research Institute.

1.3.8 “ICT” means Information Communication and Technology.

1.3.9 “LCD” Liquid Crystal Display.

- 1.3.10 "M & E" means Monitoring and Evaluation.
 1.3.11 "M. Sc" means Master of Science.

PART II —ROLE AND MANDATE OF PUBLIC HEALTH OFFICERSTECHNICIANS COUNCIL

2.1 Purpose

The purpose of the Council is—

- (2) to exercise general supervision and control over the training, practice and employment of public health officers and technicians in Kenya and to advise the government in all aspects thereof;
- (3) to regulate and maintain standards of public health training and practice.

PART III —STANDARDS ON GOVERNANCE

3.1 Vision and Mission statements.

- 3.1.1 Training institution shall have vision and mission statements which clearly and succinctly indicate its strategic direction.
- 3.1.2 The vision statement shall clearly outline what the training institution desires to be.
- 3.1.3 The mission statement shall incorporate elements of the training institutional business purpose and values, succinctly describing why it exists and what it does to achieve its vision.
- 3.1.4 Statements of vision and mission shall be prominently displayed and appear in key documents of the institution.

3.2 Leadership and Management

- 3.2.1. A training institution shall align its leadership, governance and management structure to the institution's mandate and other legal requirements.
- 3.2.2 The training institution shall—
 - (a) have clear organizational and administrative charts showing the interrelationships of the various organs and offices;
 - (b) have documented policies that include human resources policy, research policy, Information Communication and Technology policy, disability policy, curriculum development policy and Internal Quality Assurance Policy;
 - (c) have an operational strategic plan linked to the National Health priorities, policy and plans on health and development;
 - (d) develop guidelines, standards, rules and regulations in—
 - (i) student conduct and discipline;
 - (ii) staff code of conduct;
 - (iii) terms and conditions of service for staff;
 - (iv) student handbook containing admission requirements and fees guideline;
 - (e) have, if the training institutions has established independent entities, colleges or schools—
 - (i) a management board or council;
 - (ii) criteria for constitution of the board or council;
 - (iii) meetings in accordance to the institution's performance contract;
 - (iv) members representing the interests of the sponsor, but, members of the sponsoring family in case of a sponsor who is an individual, or members of the sponsoring entity in case of the institutional sponsor, may not constitute one third of the management council;

- (v) a third of its members being Kenyans in the case of a foreign sponsor.

3.2.3 The training institution shall ensure that there is clear separation of powers between the governing organs, and in particular, no one person shall head two organs whose relationship is oversight in nature.

3.2.4 The training institution shall have a financial system and a manual with clear policies and procedures on receipt of monies, budgeting procedures, expenditure and auditing.

3.2.5 The financial system shall be transparent, auditable and accountable and the institutional finances shall be managed by certified accounting personnel.

3.2.6 The training institution shall have a human resource guideline or manual with guidance on managing and developing human resource with clear job descriptions, career development, gender, staff retention policy, and disability policy.

3.2.7 The head or its equivalent of a training institution shall possess—

- (a) a minimum of a Master's degree in Environmental Health or Public Health or its equivalent with at least three years of post-qualification teaching or field experience and an additional basic qualification in the field of Environmental Health from a recognized Institution; or
- (b) a Bachelor's degree in Environmental Health from a recognized institution and at least five years of post-qualification teaching or field experience in the field of Environmental Health; and
- (c) a valid professional practicing license issued by the Council.

3.2.8 The teaching staff of an institution shall meet the qualifications outlined in the standards and guidelines for academic programs as provided for in the Council standards.

3.2.9 The training institution shall have qualified technical staff for running the Environmental Health programs in the ratio of 1:15.

3.2.10 The training institution shall have a minimum number of three laboratories each manned by three qualified technicians. The laboratories shall include—

- (a) food quality control lab;
- (b) meat pathology and inspection;
- (c) chemistry lab;
- (d) building lab or demonstration ground.

3.2.11 The administrative staff of the training institution shall have relevant qualification in their areas of operation.

3.2.12 The training institution shall clearly articulate its appointment criteria.

PART IV—STANDARDS ON CURRICULUM

4.1 Curriculum structure.

4.1.1 The training institution shall have a curriculum that will ensure the acquisition of knowledge, skills and attitudes to provide quality Environmental Health services.

4.1.2 curriculum must contain the minimum content as outlined in the Council core curriculum.

4.1.3 Each Environmental Health academic program structure shall consist of—

- (a) the training institution background information, which includes—
 - (i) the vision, mission and philosophy of the training institution and that of the department teaching environmental health;
 - (ii) academic resources for the support of the program;
 - (iii) academic organization of the program.
- (b) information on the various facets of the program including—
 - (i) the title;
 - (ii) philosophy;

- (iii) rationale including market survey implications;
- (iv) goal;
- (v) expected learning outcomes of the program;
- (vi) mode of delivery;
- (vii) academic regulations comprising of admission requirements, regulations on credit transfer, program requirements, student assessment policy criteria, grading system, examination regulations including moderation of examinations, graduation requirements, and regulations for thesis, dissertation and projects, where applicable;
- (viii) program evaluation;
- (ix) management and administration;
- (x) list of courses or units;
- (xi) duration and structure;
- (xii) course distribution table;
- (xiii) course descriptions for each course including, course title, purpose, expected learning outcomes, content, mode of delivery, instructional materials and equipment, assessment, reference materials including textbooks, journals and e-materials;
- (xiv) appendices of the academic resources for the support of the program comprising of the facilities, equipment and teaching materials, core-texts and journals, academic staff, and the University Policy on Curriculum Development.

4.2 Curriculum Design and Implementation.

4.2.1 Various facets of an academic program shall be linked and the training institutional information shall be cascaded down to the program, while the program general information shall be cascaded down to the various courses of the program.

4.2.2 The course title shall be reflected in the purpose of the course and the course's expected learning outcomes.

4.2.3 The expected learning outcomes shall be reflected in the course content, which shall be linked to the mode of delivery, instructional materials and equipment, assessment and reference materials.

4.2.4 Environmental Health Training curriculum shall be designed to—

- (a) enable the students to acquire the Environmental Health knowledge, skill and attitudes necessary for the scope and standard of practice consistent with the required level of registration or licensure;
- (b) be in line with the Health Rights as prescribed in the Constitution of Kenya.

4.3 Levels of training.

Each level of Environmental Health training academic program shall be differentiated by specific attributes. Higher levels of academic program shall require more complex attributes according to Bloom's Taxonomy. The differentiation shall be as follows—

- (a) Certificate in Environmental Health — at this level the Environmental Health officer is prepared to provide promotive, preventive health care to the community. The Environmental Health Technicians' functions are at operational level under the direction of the registered Environmental or Public Health Officers.
- (b) Basic Diploma in Environmental Health — this program the Environmental or Public Health Officer is prepared in Environmental Health practice and supervision, field and teaching experience, Environmental Health inspection and research. The Environmental or Public Health Officers' functions are at operational and supervisory levels.
- (c) Post Basic Diploma in Environmental Health — in this program the Environmental or Public Health Officer is prepared in a branch of Environmental Health such as Solid Waste Management, Food Hygiene and Safety, Water and Sanitation, Health Education and Promotion, Occupational Health and Safety, Community Health, Environmental

Pollution, Disease Surveillance among others. They have competencies in line with the field of specializations.

- (d) Bachelor's Degree Programs — in this program the Environmental or Public Health Officer is prepared in Environmental Health practice and management, field and teaching experience, Environmental Health inspection and research. The Environmental or Public Health Officer's functions are at supervisory and managerial levels.

PART V—STANDARDS ON ACADEMIC STAFF

5.1 A training institution shall have adequate and competent academic staff with relevant qualifications and teaching experience in Environmental Health to offer Environmental Health science programs for teaching core areas in the profession which include—

- (a) basic sciences;
- (b) community health;
- (c) water sanitation and hygiene;
- (d) disease prevention and control;
- (e) pollution control;
- (f) built environment and planning;
- (g) food safety and quality control;
- (h) occupational health and safety;
- (i) environmental health legislation and enforcement;
- (j) port health;
- (k) research and research methods.

5.2 Teaching staff for Environmental Health sciences must have basic training in Environmental Health and specialization in any of the core professional pillars.

5.3 training institution established or intending to establish Environmental Health training should have a minimum of seven academic staff in addition to other support staff, two thirds of whom shall be fulltime.

5.4 As a general rule, the ratio of faculty to students for Environmental Health program shall be 1:8 in line with World Health Organization guideline for practical demonstrations.

5.5 Every Environmental Health lecture shall not have more than forty students.

5.6 Faculty qualification shall be dependent on the level of training. These levels shall include—

- (a) for Certificate and Diploma — A minimum of Higher National Diploma in the field of Environmental health and three years teaching or field experience or Bachelor's degree in Environmental Health and a three years' work experience in the field of Environmental Health;
- (b) for Higher National Diploma — a minimum of Bachelor's degree in Health and a three years' experience in the field of Environmental Health;
- (c) for Bachelor's degree — Master's degree in Environmental Health or Public Health or equivalent qualification and an additional basic qualification in the field of Environmental Health with a minimum of five years teaching or field experience;
- (d) for Post Graduate Diplomas — Master's degree in Environmental Health or Public Health or equivalent qualification and an additional basic qualification in the field of Environmental Health with a minimum of five years teaching or field experience.

PART VI—STANDARDS ON PHYSICAL RESOURCES.

6.1 Standards on physical resources.

Every training institution offering or intending to offer Environmental Health shall provide, as a minimum, the following facilities —

- (a) lecture rooms;
- (b) departmental areas;
- (c) staff offices;
- (d) seminar rooms;

- (e) central administration offices;
- (f) library;
- (g) auditorium or lecture theatre;
- (h) staff common rooms;
- (i) student common rooms with indoor recreation facilities;
- (j) outdoor recreation facilities in form of games or sports facilities;
- (k) drainage system, proper sanitation and water supply;
- (l) Information Communication and Technology infrastructure;
- (m) kitchen and dining facilities;
- (n) student accommodation, including adequate laundry and storage as per the Public Health Act and building code guidelines.

6.2 Location of a training institution.

- 6.2.1 Environmental Health training institution shall be located in a secure location with adequate space.
- 6.2.2 The department of Environmental Health shall have an administration block that shall house the office of the head of department.
- 6.2.3 The academic leader's seat of the Environmental Health training shall be located at the main campus.
- 6.2.4 An Environmental Health training institution shall be on adequate land to facilitate program implementation.
- 6.2.5 An online Environmental Health training institution shall, in accordance with these standards, have a physical seat that shall serve as the administrative center and shall meet the curriculum standards for online programs.

6.3 Colleges and Satellite Campuses.

- 6.3.1 Environmental Health training department in colleges and satellite campuses shall be in facilities that meet the Council's accreditation standards.
- 6.3.2 Facilities used as training institutions shall be accredited independently.
- 6.3.3 Facilities and services at a campus shall be of the same standards as those at the main campus.

6.4 Learning Environment.

- 6.4.1 Environmental Health training institutions, colleges and satellite campuses shall not be located in environments that could be injurious to the health of students, destructive or noisy. These include but are not limited to—
 - (a) factories;
 - (b) dumping sites;
 - (c) quarries;
 - (d) bars;
 - (e) night clubs;
 - (f) casinos;
 - (g) airports;
 - (h) bus parks;
 - (i) markets ;and
 - (j) such other similar establishments.

- 6.4.2 A training institution shall maintain proper and adequate directional signage in all its facilities to ensure ease of movement in all areas.

6.5 Conformance to Statutory Requirements.

- 6.5.1 Every building used or intended to be used as part of the training institution physical facility shall comply with the requirements of the Building Code of the Republic of Kenya and provisions of the Public Health Act, Occupational safety and Health , Environmental Management and Coordination Act 1999 and any other statutory requirements.
- 6.5.2 All buildings and other physical facilities used by a training institution shall have—

- (a) approved architectural and structural drawings of the complete and proposed buildings;
- (b) approval for alterations or extensions, if any;
- (c) approval of proposed change of user if any;
- (d) certificate of occupation for the newly constructed or altered buildings;
- (e) Impact Assessment certificate by National Environment Management Authority;
- (f) provisions to accommodate persons living with disabilities;
- (g) any other statutory approval as may be required.

6.6 Recreational facilities.

- 6.6.1 Every training institution shall provide adequate indoor and outdoor sports and recreational facilities for students and staff.
- 6.6.2 Where sports and recreational facilities are leased or shared the Environmental Health training institution shall procure a legally binding memorandum of agreement.

6.7 Residential students.

- 6.7.1 Students' accommodation in an Environmental Health training institution shall be provided in facilities that are adequate, safe, well lit and ventilated.
- 6.7.2 Rooms used as student accommodation shall house not more than four students per room. guidelines shall be reviewed every four years or as need arises.
- 6.7.3 Every room shall be provided with maximum benefit of natural light and natural ventilation.
- 6.7.4 Sufficient doorways shall be provided in every student hall to ensure rapid exit in case of fire or other emergencies.
- 6.7.5 The total floor area of rooms used as student accommodation shall not be less than the following area—
 - (a) single room, 8.00 meters square;
 - (b) double student room or cubicle, 14.00 meters square;
 - (c) three or four student room 18.00 meters square.

6.8 Utility Services.

- 6.8.1 Every training institution shall have adequate, safe and reliable water supply installed in accordance with the requirements of the Building Code of the Republic of Kenya.
- 6.8.2 The water shall be wholesome, free from any contamination that may cause disease or injury to health, has no objectionable taste and odour, is aesthetically acceptable and has been certified as such by a recognized water laboratory.
- 6.8.3 The water provided shall conform to the requirements of the Kenya National Drinking Water Standards set out in the latest edition of the Practice in Water Supply Services in Kenya issued by the ministry, for the time being, in charge of Water Services.
- 6.8.4 The training institution shall make available cold water storage facility in each building for domestic purposes taken from the main supply to the buildings or cold water storage tank in each building with sufficient capacity to meet not less than twenty four hours demand from the building's users or a minimum water demand of one hundred and fifty litres per day per person.
- 6.8.5 Every training institution shall make provisions for water harvesting to supplement the main water supply.

6.9 Academic and non-academic staff Offices.

- 6.9.1 Every training institution shall provide adequate room to accommodate academic and non-academic staff offices and boardroom.
- 6.9.2 Minimum department's usable areas per full time student equivalent should be as follows—
 - (a) the departmental offices shall comprise of the following minimum number of offices—
 - (i) one departmental office;

- (ii) one head of department office;
- (iii) one secretary's office;
- (iv) one office for every two members of academic staff or workstation for each staff;
- (b) academic and non-academic members' staff offices shall have the following minimum floor areas—
 - (i) head of department and professors—eighteen square meters;
 - (ii) shared academic staff—eighteen square meters;
 - (iii) non-academic staff—seven square meters;
- (c) the total office space provided for use by administrative staff shall not be less than 0.55 square meters of usable office space for every full time student equivalent enrolled;
- (d) a room used as an administrative office shall not be less than seven square meters in area.

6.10 Office and Lecture Room Spaces

- 6.10.1 Every training institution shall provide lecture rooms which are adequate in number and size and are well lit and ventilated.
- 6.10.2 In establishing the adequacy of lecture rooms, the minimum floor area per student specified shall be as provided for in the First Schedule.
- 6.10.3 The total usable space provided for lecture rooms shall be at the minimum rate of 0.65 square meters per full time student equivalent.
- 6.10.4 A training institution shall provide a minimum of three lecture rooms to each three-year course of study.
- 6.10.5 Every room used as a lecture room shall be —
 - (a) of sound construction;
 - (b) provided with—
 - (i) lighting and ventilation in line with Public Health Act and Building Code;
 - (ii) well illuminated writing surface at each seat and a place to set books and papers.

6.11 Teaching Laboratories and Workshops.

- 6.11.1 A training institution shall, in addition to providing lecture rooms and lecture theatres provide adequate laboratory facilities.
- 6.11.2 Laboratory facilities should be adequate and in close proximity to lecture room or teaching facilities for ease of access.
- 6.11.3 Laboratories or specialized facilities should have room for instructional workstations.
- 6.11.4 Every laboratory shall have provision for storage and preparatory rooms in addition to a laboratory office.
- 6.11.5 A laboratory shall be provided with the following service facilities—
 - (a) adequate windows which open to outside air in order to provide proper ventilation;
 - (b) fume cupboards and fume hoods in the preparation and storage rooms;
 - (c) standard table top electrical service outlets for the instructor's table and for each pair of students workstation;
 - (d) adequate lighting free of glare from exterior sunlight;
 - (e) surface treatment of floors, walls and ceiling to reduce noise;
 - (f) a sink with hot and cold water service installation for the instructor's table and for each pair of student's workstation;
 - (g) gas for the instructor's table and for each pair of students' workstation.

- 6.11.6 A laboratory shall have built-in furniture and equipment and equipment including—

- (a) at least one student table of minimum dimensions of 2000 x 300 x 760mm;
- (b) least one student table of minimum dimensions of 1500 x 560 x 760mm for each pair of student's workstation with adequate bench or stools or chairs;
- (c) chalkboard or tack board, wall mounted; and
- (d) at least one corrosion resistant sink and eye-wash fountain.

PART VII—STANDARDS ON SAFETY

7.1 Structural safety.

- 7.1.1 Every Environmental Health training institution shall operate in facilities and structures that are safe for the public as provided for in the Building Code of the Republic of Kenya.
- 7.1.2 All buildings and other physical facilities used by a training institution to accommodate Environmental Health training activities shall —
 - (a) be serviceable and functional.
 - (b) be kept in a good state of repair and maintenance.
 - (c) be structurally sound and secure for users from hazards as falling, slipping and tripping.
 - (d) have in place mechanisms to minimize or avoid security risks associated with users.

7.2 Fire Safety.

- 7.2.1 All buildings and other physical facilities used by an Environmental Health training institution to accommodate Environmental Health training institution activities shall provide for adequate fire safety.
- 7.2.2 Every Environmental Health training institution shall ensure that—
 - (a) all buildings and other physical facilities shall conform to the requirements of the Public Health Act, the Building Code of the Republic of Kenya and other standard practices with regard to fire resistance, means of fire escape, access from fire escape and fire-fighting equipment;
 - (b) all means of fire escape shall be properly maintained and kept free from any obstruction;
 - (c) doors for lecture rooms, lecture theatres and other large rooms use for public purpose shall open outwards;
 - (d) large lecture rooms, lecture theatre or halls shall have a minimum of two doors;
 - (e) adequate and appropriately placed fire-fighting equipment such as hose reels, portable fire extinguishers, fire buckets, dry risers, fire hydrants, sprinkles, and water storage tanks in every building are provided;
 - (f) the institution is provided with a water supply system for fire-fighting and the water for emergency fire-fighting purposes shall be drawn through the main water supply distribution system via a series of underground hydrants located at regular intervals throughout the site the Environmental Health training institution;
 - (g) the institution has designated emergency assembly points and conducts quarterly emergency drills;
 - (h) the institution shall designate a fire marshal that would ensure maintenance of fire-fighting equipment.

7.4 Provisions for persons living with disability.

- All buildings used for Environmental Health training institution activities shall have adequate provisions to cater for the physically challenged and should provide—
 - (a) a ramp, a lift or other means to enable access to the facilities by the physically challenged;
 - (b) modified toilets for the physically challenged as specified in the appendix to the sixth schedule of the building code.

7.5 Public Health and safety.

7.5.1 Every training institution shall provide, keep clean and maintain adequate and suitable sanitary conveniences which conform in all respects to the requirements of the Public Health Act, Occupational Safety and Health Act, persons with disabilities act and Building Code of the Republic of Kenya, for students and all persons working in the training institution.

7.5.2 Where students or other persons of both sexes are accommodated or are expected to be accommodated, the conveniences shall afford proper separate facilities for persons of each sex.

7.5.3 In a non-residential training institution, the following well lighted and ventilated closets, urinals, wash hand basins with soap and drinking water fountains shall be provided—

- (a) one water closet for every eight female students;
- (b) one water closet for every ten male students;
- (c) one urinal stall for every twenty five male students;
- (d) onewash hand basin with soap for every six students;
- (e) one drinking water fountain for every twelve students; and
- (f) a sanitary pad storage facility for every female unit.

7.5.4 In a residential training institution the following well lit and ventilated closets, urinals, wash hand basins with soaps, bathrooms and drinking water fountain shall be provided—

- (a) one water closet per every fifteen male students;
- (b) one water closet per every ten female students;
- (c) one urinal per every ten students;
- (d) one wash hand basin per every ten students;
- (e) one bath or shower per every ten students;
- (f) one bath or shower per every eight female students;
- (g) one drinking water fountain for every twenty students; and
- (h) a sanitary pad storage facility for every female unit.

PART VIII—STANDARD ON PRACTICUM SITES AND PLACEMENT AREAS

8.1 Standard on practicum sites and placement areas.

8.1.1 Every training institution shall identify and sign a memorandum of understanding with relevant practicum sites for purposes of student practical learning.

8.1.2 All training institutions shall identify —

- (a) practicum sites with the opportunities to learn different environmental health key areas and application of principles they have learnt in class.
- (b) community based health care facilities where they will have the opportunity to understand the health care system and its application as well as disease surveillance.
- (c) industries and food processing plants relevant to Environmental Health for purposes of practical acquisition of knowledge and competencies.
- (d) law courts where students will be exposed to the processes of law enforcement relevant to Environmental Health.

8.1.3 For purposes of the guidelines in paragraph 8.1.2 above, the training institution shall ensure that students acquire skills in the areas set out in the Second Schedule based on the year of study in line with the core curricula.

8.2 Equipment and Educational Resources.

8.2.1 Every Environmental Health training institution shall put in place adequate equipment to support teaching and learning. These include—

- (a) lecture theatres shall have mounted liquid crystal display projectors, flip charts, white boards and relevant utilities;
- (b) an Environmental Health computer laboratory which shall have fourty computers installed with

ArchiCAD software for technical design and drawing. The laboratory shall have at least one printer with a capacity to produce drawing plans generated from the software above;

- (c) a physical laboratory adequately equipped with building construction materials, public health engineering materials, demonstration models and drainage and plumbing materials and occupational health and safety equipment such as —
- (d) sound level meters;
- (e) air sampling pumps;
- (f) personal protective equipment;
- (g) hygrometers;
- (h) a fully equipped food hygiene and safety laboratory for Food Science, water, soil, wastes and air;
- (i) meat Pathology Laboratory with functional cold storage facility and model specimens of bovine, shoats, swine, camel, donkey, zebra, rabbit, cat, and preserved animal parasites;
- (j) environmental Health biological laboratory shall have the biological microscopes, incubators, hot air ovens, autoclaves, fume cabinets, centrifuges, refrigerators, freezers, water distillers, electric balances, analytical balances and pH meter;
- (k) hygiene Reference Bank that shall have reference material on hygiene.

PART IX—STANDARD ON INFORMATION AND COMMUNICATION TECHNOLOGY

9.1 A training institution shall be able to use information and communication technology for self-learning and accessing information. Each institution shall have—

- (a) a minimum student to computer ratio of 1:1;
- (b) reliable internet access with minimum of 1 Mbps bandwidth;
- (c) an e-library and access to e-journal portals.

PART—STANDARD ON STUDENTS.

10.1 training institution shall have a student population that meets the admission requirements as stipulated in the indexing guidelines, and in numbers that can be supported by faculty and physical resources as outlined in the Council training standards.

10.2 Every training institution shall have a clear admission policy that includes the selection criteria as per the Council Core curriculum.

10.3 Students must be indexed within ninety days from date of admission.

10.4 The number of students per intake shall be in line with the available resources in the department and practicum area.

10.5 Every training institution shall have —

- (a) the ability to provide academic support, career guidance and counseling and health services;
- (b) proper welfare management in place which provides for—
- (c) a policy on student representation, appropriate participation in the design, management, and evaluation of the curriculum and in other matters relevant to students;
- (d) adequate recreational facilities;
- (e) adequate and suitable accommodation;
- (f) health insurance cover.
- (g) appropriate lab-coat and relevant PPE during field and industrial visits, practicum placements as per the Council policy.
- (h) in place a student retention system.

PART XI—STANDARD ON PROGRAM EVALUATION

11.1 A training institution shall establish mechanism for evaluation of Environmental Health program which shall—

- (a) use M&E plans, strategies and schedule;
- (b) carryout periodical program audit.

PART XII—STANDARD ON QUALITY ASSURANCE

- 12.1 A training institution shall establish a system for continuous quality improvement which —
- complies with statutory and regulatory requirements;
 - complies with internal policies, procedures and plans;
 - provides for regular performance appraisal and training needs assessment;
 - provides for policy on quality assurance and continual improvement;
 - provides for a Quality Management System; and
 - provides for personnel training in quality assurance.

PART XIII —STANDARD ON RESEARCH

- 13.1 A training institution shall promote and conduct research as an integral part of professional development and foster evidence based practice. The Institution should ensure—
- there is an institutional research policy that describes the relationship between research priorities, facilities and educational programs;
 - there are research facilities, infrastructure and resources to support research activities;
 - there are mechanisms and forums to document and disseminate research finding widely;
 - the training institution has established a functional research committee;
 - there is a current research strategy including prioritized thematic areas for research and related work plans;
 - staff are facilitated and provided with opportunities to undertake research.

A person shall not engage in the teaching service unless such person is registered as a teacher under this Act - Article 23 (2).

Any person who:

(a) Not being a registered teacher, teaches or assists in teaching in any school, shall be guilty of an offence.

(b) Permits or employs to teach in any school a person not being a registered teacher, shall be guilty of an offence.

Persons cited in categories (a) and (b) above shall, in accordance with Regulation 18 (1) (d) of the Code of Regulations for Teachers, be liable to a fine not exceeding five thousand shillings or to imprisonment for a term not exceeding six months, or to both such fine and such imprisonment.
