NOTICE is given that pursuant to the provisions of section 20 (6) of the Crops Act, 2013 and the Coffee Form Rules, 2012 the Coffee Directorate of AFFA has published the list of applicants for the grant of licenses to various persons who wish to provide services in the coffee industry for the year 2015/2016.
