## NATIONAL TASKFORCE ON REPATRIATION OF REFUGEES ${\bf APPOINTMENT}$

IT IS notified for the general information of the public that the Cabinet Secretary for Interior and Co-ordination of National Government, in furtherance of the decision of the Government to repatriate refugees, appoints a National Taskforce on Repatriation of Refugees.

1. The Taskforce shall comprise-

- 2. The Terms of Reference of the Task Force are to-
  - (a) Develop modalities, timelines and costs for the repatriation of refugees in Kenya.
  - (b) Develop refugee management and control strategies during the period of repatriation.
  - (c) Develop a verification criteria for refugees that will feed into a comprehensive refugee database.
  - (d) Develop a plan for the provision of security during the repatriation process.
  - (e) Develop a sensitization programme for refugee host communities on the repatriation exercise.
  - (f) Examine and recommend appropriate legal and policy framework to enable repatriation in light of existing laws and conventions.
  - (g) Identify emerging international practices in refugee management in the context of national security considerations.
- 3. In performance of its functions, the Taskforce may-
  - (a) Conduct any other activities required for effective discharge of its mandate.
  - (b) Co-opt any relevant person to assist in the effective discharge of its mandate.
- The Taskforce shall submit its report to the Cabinet Secretary, Interior and Co-ordination of National Government by 31st May, 2016.
