THE SENATE STANDING ORDERS

SPECIAL SITTING OF THE SENATE

NOTICE is given to all Senators that pursuant to standing order 29 of the Senate Standing Orders, on the request of the Senate Majority Leader with the support of the requisite number of Senators, I have appointed Friday, 5th August, 2016 as a day for a Special Sitting of the Senate. The Special Sitting shall be held in the Senate Chamber, Ground Floor, Main Parliament Buildings, Nairobi, at 9.30 a.m.

The business to be transacted at the Special Sitting shall be the consideration of-

- (a) The County Government's Cash Disbursement Schedule for the Financial Year 2016/2017 for the period July, 2016 to June, 2017;
- (b) The Report of the Mediation Committee on the Community Land Bill, 2015 (National Assembly Bills No. 45 of 2015);
