THE KENYA INFORMATION AND COMMUNICATIONS ACT

(No. 2 of 1998)

TRANSITION PERIOD FOR RADIO BROADCASTING PERMITS GRANTED BY THE MINISTRY OF INFORMATION, COMMUNICATIONS AND TECHNOLOGY.

IN EXERCISE of the powers conferred by Paragraph 2 of the Fifth Schedule to the Kenya Information and Communications Act, 1998, and pursuant to the Ruling of the High Court delivered on 22nd July, 2016 in NRB. HC Petition No. 244 of 2011, the Cabinet Secretary, Ministry of Information, Communications and Technology notifies the public as follows:

All holders of Radio Broadcasting Permits issued by the predecessors of the Ministry of Information, Communications and Technology are granted a further one year period effective 2nd January, 2016 (the Transition Period) during which period they are deemed to continue to operate in accordance with their existing permits.

During the Transition Period the holders of the said Radio Broadcasting Permits shall be required to apply to the Communications Authority of Kenya for issuance of the relevant licenses within the context set out in the Kenya Information and Communications Act, 1998, and in accordance with the terms and conditions of the licenses to be issued by the Authority.

The applications for licenses shall be in such format or manner and within such timelines as prescribed by the Authority from time to time within the Transition Period or any extension thereof.
