DECLARATION OF CERTAIN ADMINISTRATIVE LOCATIONS OF BARINGO  
COUNTY AS DISTURBED AND DANGEROUS AREAS

IN EXERCISE of the powers conferred by section 106 (2) (a) of the National Police Service Act (No. 11A of 2011) and pursuant to Legal Notice No. 20 of 2017, declaring certain Administrative Locations of Baringo County as Disturbed and Dangerous Areas, the Inspector-General of Police notifies the general public that all inhabitants of the location/areas covering: Arabal, Kiserian, Mochongoi, Rugus, Mukutani, Chebinyiny, Komolion, Chepkalacha, Makutano, Paka, Orus, Loiywat, Silale, Nando, Tangelbei, Chepkererat, Kipnai, Ng'oron, Amaya are prohibited to possess any arms.

Upon publication of this notice, all persons/inhabitants are ordered to surrender all arms in their possession with immediate effect to the nearest Police Station/Post/Camp or Administrative office during the hours of the day for safe custody.

This Notice shall take effect from the date of publication and shall remain in force for a period of thirty (30) days subject to revocation and/or extension.

DECLARATION OF CERTAIN ADMINISTRATIVE LOCATIONS/WARDS OF  
LAIKIPIA COUNTY AS DISTURBED AND DANGEROUS AREAS

IN EXERCISE of the powers conferred by section 106 (2) (a) of the National Police Service Act (No.11A of 2011) and pursuant to Legal Notice No. 21 of 2017 declaring certain Administrative Locations/Wards of Laikipia County as Disturbed and Dangerous Areas, the Inspector General of Police notifies the general public that all inhabitants of the location/areas covering: Rumuruti Division, Ol Moran Division, Kirimon Division, Ng'arua Division (Mithiga and Matuiku Locations only), Marmanet Division (Salama Location only), Segera Division (Segera Location only) and Mukogodo East Division are prohibited to possess any arms.

Upon publication of this Notice, all persons/inhabitants are ordered to surrender all arms in their possession with immediate effect to the nearest Police Station/Post/Camp or Administrative office during the hours of the day for safe custody.

This Notice shall take effect from the date of publication and shall remain in force for a period of thirty (30) days subject to revocation and/or extension.
