# THE CONSTITUTION OF KENYA THE COUNTY GOVERNMENTS ACT, 2012

(No. 17 of 2012)

#### THE INTERGOVERNMENTAL RELATIONS ACT, 2012

(No. 2 of 2012)

#### FRAMEWORK FOR THE ASSUMPTION OF THE OFFICE OF GOVERNOR

IT IS notified for the information of the general public that pursuant to the provisions of Article 189 (2) of the Constitution, section 121(1) of the County Governments Act, 2012 and section 23 of the Intergovernmental Relations Act, 2012, the Cabinet Secretary for Devolution and Planning has issued the guidelines set out in the Schedule as a framework for the procedure and ceremony for the assumption of the office of the Governor-elect.

#### SCHEDULE

Establishment of the Assumption of the Office of Governor Committee.

- (1) Each county shall establish a Committee to be known as the Assumption of Office of the Governor Committee (hereinafter referred to as the "the Committee").
- (2) The Committee shall be an ad hoc Committee and shall consist of—
  - (a) the County Secretary who shall be the chairperson;
  - (b) the County Commissioner;
  - (c) the officer in charge of legal matters in the county;
  - (d) the Chief Officer in the department responsible for matters relating to the county public service;
  - (e) the Chief Officer in the department responsible for matters relating to Information and communication;
  - (f) the Chief Officer in the department responsible for matters relating to finance;
  - (g) the Chief Officer in the department responsible for matters relating to public works, roads and transport;
  - (h) the head of National Police Service in the County;
  - (i) the head of the National Intelligence Service in the County;
  - (j) the Clerk of the County Assembly;
  - (k) one County Assembly official nominated by the clerk of the County Assembly;
  - a representative of the Ministry of Devolution and Planning;
     and
  - (m)a representative of the Intergovernmental Relations Technical Committee.
- (3) Immediately upon the declaration of the results of the elections by the Independent Electoral—and Boundaries Commission, the Governor-elect shall nominate two persons to sit in the Committee.
- (4) The Chief Officer in the department responsible for matters relating to the county public service and the representative of the Ministry of Devolution and Planning shall be the joint secretaries to the Committee.
- (5) A vacancy in the membership of the Committee shall not affect the decisions of the Committee.
- (6) The quorum for the conduct of business of a meeting of the Committee shall be one-half of all the members of the Committee.
- (7) In the absence of the chairperson, the members of the Committee shall elect a chairperson from amongst their number.
- (8) The Chairperson of the Committee shall convene the first meeting of the Committee not more than thirty calendar days before the date of the general elections.
- (9) The term of office of a Committee established under this paragraph shall lapse thirty days after the swearing in of the Governorelect.

#### Functions of the Committee

- 2. (1) The functions of the Committee shall be to-
- (a) facilitate the handing over process by the outgoing Governor to the Governor-elect:
- (b) co-ordinate the provision of the security of the Governor-elect;
- (c) co-ordinate the provision of the necessary facilities and personnel for the Governor-elect;
- (d) co-ordinate the briefings of the Governor-elect by the relevant county public officers which shall include, but not be limited to the following —
  - (i) an up-to-date assets register;
  - (ii) an up-to-date register of liabilities;
  - (iii) a complete list of all bank accounts and reconciled balances;
  - (iv) a report of staff establishment per department;
  - (v) a comprehensive report on county entities (corporations) and agencies containing information outlined in (i) to (iv);
  - (vi) a report on all ongoing projects including donor funded projects;
  - (vii) an up-to-date report on all pending legal cases; and
  - (viii) county source of funding.
- (e) facilitate communication between the outgoing Governor and the Governor-elect;
- (f) prepare the programme and organize for the swearing-in ceremony; and
- (g) carry out any other activity necessary for the performance of its functions under this framework.
- (2) The information to be provided during the briefings referred to under paragraph 2 (1) (d) shall be prepared in the manner set out in the Annexure to this framework.

#### Sub-committees

- 3. (1) The Committee may establish such sub-committees for the better carrying out of its functions as it may consider necessary.
- (2) The Committee may co-opt into a sub-committee established under subparagraph (1), persons whose knowledge and skills are necessary for the effective functioning of the Committee:

Provided that the Committee shall not co-opt more than two persons.

#### Procedure of the Committee

- (1) Except as otherwise provided in this framework, the Committee shall determine its own procedure.
- (2) Despite subparagraph (1), the decisions of the Committee shall be by consensus:

Provided that where there is no consensus the decision of the Committee shall be taken by the vote of a simple majority and the Chairperson of the Committee shall have a casting vote in the event of a tie.

#### Security for Governor-elect

- 5. (1) Upon the declaration of the final results of the election for the Office of Governor by the Independent Electoral and Boundaries Commission under Article 180 of the Constitution and section 39 of the Elections Act, the Committee shall ensure that the Governor-elect and Deputy Governor-elect are accorded adequate security.
- (2) The provisions of subparagraph (1) shall be subject to any order given by the Court where a petition is filed against the results declared by the Independent Electoral and Boundaries Commission.

#### County public officers to provide required information

- (1)The Committee shall in consultation with the Governor-elect, carry out such preparations as may be necessary for the purpose of assuming office.
- (2) The Committee may, in carrying out preparations in accordance with its mandate, request, in writing, for such information and documents from a county public officer as it may consider necessary.

(3) A county public officer from whom information is requested under subparagraph (2) shall provide the information within 72 hours from the time of receipt of the request of the information.

#### Swearing-in ceremony

- 7. (1) The swearing-in of the Governor-elect shall be conducted in a public ceremony before a High Court Judge, or in the absence of a High Court Judge, a Chief Magistrate.
- (2) The Committee shall publish, by notice in the Gazette, the date, time and place for the conduct of the swearing-in ceremony.
- (3) The Governor-elect shall be sworn-in on the tenth day after the declaration of the results of the election of county governor.

#### Taking of oath and signing of certificate of inauguration.

- 8. (1) The Governor-elect shall, during the swearing-in ceremany, take and subscribe to the oath or affirmation of office as provided in the First Schedule of the County Governments Act, 2012.
- (2) The Oath or affirmation under subparagraph (1) above shall be administered not earlier than 9.00 a.m. and not later than 5:00 p.m.
- (3) Upon taking or subscribing to the oath or affirmation under subparagraph (1), the Governor shall sign a certificate of inauguration in the presence of a High Court Judge or in the absence of a High Court Judge, the Deputy Registrar.
- (4) Upon signing the certificate of inauguration, the outgoing Governor shall handover to the Governor-elect any of the following county symbols as a sign of transfer of executive power and authority—
  - (a) the county flag;
  - (b) the county coat of arms; or
  - (c) the county public seal.
- (5) Where the outgoing Governor is not present during the inauguration the county symbols shall be handed over to the Governor-elect by the presiding Judge or the Deputy Registrar, as the case may be.
- (6) The failure by the outgoing Governor to hand over the county symbols to the Governor-elect shall not invalidate or hinder the swearing in of the Governor-elect.
- (7) Where the outgoing governor is re-elected for a second term and upon signing the certificate of inauguration, the presiding Judge of the Deputy Registrar as the case may be shall hand over to the Governor any of the county symbols.

#### Swearing-in of the Deputy Governor-elect.

 The Deputy Governor-elect shall take and subscribe to the eath or affirmation of office as prescribed in the First Schedule of the County Governments Act, 2012.

#### Inaugural speech.

The Governor shall upon completion of the swearing in ceremony give an inaugural speech.

#### Security during the swearing-in ceremony

11. The County Commissioner shall ensure the provision of adequate security during the conduct of the swearing-in ceremony.

## Reports of the Committee

- 12. (1) The Committee shall, within thirty days from the date of the swearing-in of the Governor, prepare and submit a report on the affairs of the Committee, to the County Assembly and Cabinet Secretary responsible for Intergovernmental Relations.
  - (2) The report shall contain —
  - (a) the financial statements of the Committee;
  - (b) a description of the activities of the Committee; and
  - (c) any other information relating to its functions that the Committee considers necessary.

## Management of information and records.

- 13. (1) A request for information in the public interest by a citimen shall be dealt with by the Committee in accordance with Article 35 of the Constitution and the Access to Information Act, 2016.
- (2) Every member and staff assigned to the Committee shall sign a confidentiality agreement during the first sitting of the Committee.

Funding

- 14. (1) The respective County Governments shall meet the costs of the swearing-in ceremony, sitting allowances and other operational costs of their respective Committee.
- (2) Without prejudice to the provisions of sub paragraph (1), the National Government ministries, departments and agencies represented in the Committee shall meet the expenses for their officers appointed to the Committee.

Succession generally

15. The day-to-day functioning of the county government before and during the assumption of office by the Governor-elect shall be subject to the Constitution and other existing laws regarding transition and succession of institutions, offices, assets and liabilities.
