DECLARATION OF A VACANCY IN THE OFFICE OF THE SPEAKER OF NYANDARUA COUNTY ASSEMBLY

IT IS notified for the information of the general public that pursuant to section 21 of the Elections Act, the Office of the Speaker of the Nyandarua County Assembly shall become vacant upon the first sitting of the County Assembly on Tuesday, the 5th September 2017 at 9 00 a m

Article 178 of the Constitution provides that each county assembly shall have a speaker elected by the county assembly from among persons who are not members of the assembly.

Further, section 21 of the Election Act provides that the speaker of a county assembly shall be elected by each county assembly in accordance with the Standing Orders of the county assembly, from among persons who are qualified to be elected as members of a county assembly but are not such members.

Pursuant to Standing Order 4 of the Nyandarua County Assembly Standing Orders, His Excellency the Governor of Nyandarua County, through Legal Notice No. 1 of 2017, notified that the first sitting of the County Assembly shall be held at the Nyandarua County Assembly Chambers, Ol Kalou, near Huduma Centre, on Tuesday, the 5th day of September, 2017 at 9.00 a.m.

Interested persons who qualify to be elected as members of County Assembly but are not such members, are therefore invited to submit their nomination papers for election.

A nomination form in this respect shall be obtained from the Office of Clerk on any working day and within the official working hours.

Further and in accordance with the newspaper advert appearing on the Nation Newspaper of the 26th and 27th days of August 2017 on the vacancy in the Office of the Speaker of Nyandarua County Assembly, interested persons should submit the listed clearances, handwritten application letters, completed nomination papers, together with the curriculum vitae of the candidate and relevant supporting documents, should be submitted to the Office of the Clerk of the County Assembly at Nyandarua County Assembly Chambers, Ol Kalou - near Huduma Centre, 48 hours before the first sitting.
