The combined capacity of the three SHPPs is 18.5 MW. The annual generation is estimated to be to the tune of 98,509 MWh of electricity.

- Fell only the trees marked for felling; all other trees should be protected to save the forest cover in the forested area.

- Rehabilitate all degraded land during and following completion of construction activities.
- Install systems to discourage fish from entering abstraction equipment, including acoustic barriers, lighting barriers and bubble curtains.
- Retain forest cover in the forested area.
- Establish more riparian forests of indigenous trees or environmental friendly ones in agricultural areas.
- Rehabilitate all degraded land during and following completion of construction activities.
- Monitoring of biological and chemical parameters in the water and in aquatic biota to alert the proponent, relevant Government Agencies and local communities on potential hazards to aquatic habitat.
- Areas that will not be put to immediate use to be left intact.
- Excavation should not be carried out during the rainy(wet) season when animals are breeding.
- Top soil to be kept aside for use in replanting and landscaping.
- Together with experts relocate animals that move slowly and found in the site during excavation and clearing.
- Reestablish original habitat patterns to improve surface water runoffs before commencing operations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
