THE NATIONAL POLICE SERVICE ACT, 2011

(No. 11A of 2011)

EXTENSION OF THE DECLARATION OF CERTAIN ADMINISTRATIVE LOCATIONS OF BUNGOMA COUNTY AS DISTURBED AND DANGEROUS AREA (GAZETTE NOTICE NO. 2092 OF 6TH MARCH, 2018)

IN EXERCISE of powers conferred by section 106 (1) of the National Police Service Act (No. 11A of 2011), the Cabinet Secretary, Ministry of Interior Co-ordination of National Government, in consultation with the National Security Council, extends the declaration of Cheptais Sub-County in Bungoma County, as Disturbed and Dangerous for a period of thirty (30) days from 7th June, 2018 to 6th July, 2018 and shall remain in force subject to revocation and/or extension.
