Eight copies of the filled questionnaire should be returned together with 8 copies of the curriculum vitae, national identity card and certified copies of personal credential/academic certificates and other testimonials to the Office of the Clerk of the County Assembly at County Assembly Buildings not later than 5.00 p.m. on Thursday, 16th August, 2018. The nominees should also submit along with the above 8 certified copies of current clearance certificates from the following bodies:
