ESTABLISHMENT OF THE MERU COUNTY SPORTS COUNCIL

FOR the purposes of giving effect to section 30 (3) (g) of the County Governments Act which requires the Governor to promote and facilitate citizen participation in the development of policies and plans, and delivery of services in the County, it is notified for the general information of the public that, I, Kariatu Murungi, Governor, Meru County, have appointed a Council to be known as the Meru County Sports Council to enhance the development of sporting industry in the County.

The Council shall comprise the following members:

Functions of the Council

The functions of the Council shall be to:

- (a) Advise the County Executive Committee Member responsible for sports in the county on matters relating to development, promotion and co-ordination of all forms of amateur and professional sports at the county level ;
- (b) Create linkages and encourage private sector investments in the sports sector;
- (c) Strengthen the cohesion among the various structures of sporting organisations within the County;
- (d) Promote the diversification of sports to all parts and at all levels in the county;

- (e) Assist the County Government to develop policies that will ensure that the County Sports Associations at all levels conform to the national and international rules, regulations, norms, standards and codes of conduct governing a particular sport;
- (f) Encourage the development, provision and maintenance of sports facilities and advise on their equitable distribution and proper use;
- (g) Drive development of the sports sector in the County in order to provide a lasting legacy for sports in the County;
- (h) Attract strategically important sporting events to the County and ensure that they are staged to an international standard;
- (i) Advocate for sports in the County, ensuring effective communication with key stakeholders both nationally and internationally;
- (j) Contribute to the development of a commercial strategy to maintain private sector income and expertise into a high performance sports system;
- (k) Promote the welfare of all athletes and participants in the sports sector in the County;
- (l) Leverage negotiation with private corporations, government agencies, private and public foundations in matters relating to sports; and
- (m) Perform any other functions that are ancillary to the object and purpose for which the Sports Council is established.

The term for the Council shall be three (3) years; renewable for the balance of the term of the current County Government.

- (c) Promote the gradual expansion and enhancement of existing tourism facilities, services and infrastructure to provide additional activities for visitors with increased revenue potential and appeal across a broader spectrum of markets;
- (d) Support the County Government in promoting to the community the importance of tourism;
- (e) Identify tourism market needs and trends and advise tourism stakeholders accordingly;
- (f) Create linkages and encourage private sector investments in the tourism sector;
- (g) Assess County Government policies on tourism, for their effectiveness in achieving economic and social transformation, and advise accordingly.
