SPECIAL SITTINGS OF THE NATIONAL ASSEMBLY

PURSUANT to the provisions of Standing Order 29 (3) of the Standing Orders of the National Assembly, it is notified for the information of the Members of the National Assembly and the general public that Special sittings of the Assembly shall be held in the National Assembly Chamber in the Main Parliament Buildings, Nairobi on Tuesday, 18th September, 2018 commencing at 2.30 p.m. and; on Thursday 20th September, 2018 at 9.30 a.m. and at 2.30 p.m. for purposes of—

A. Notification of—

(a) the message from the President in respect of his reservations to the Finance Bill, 2018 pursuant to Article 115 of the Constitution; and,

(b) Supplementary Estimates, 2018;

B. Transacting the following business—

- (a) Second Reading, consideration in Committee of the whole House and Third Reading of the following Bills—
- (i) The County Governments (Amendment) (No. 2) Bill, Senate Bill No. 7 of 2017;
