(No. 12 of 2006)

THE SCHEDULE OF TARIFFS SET BY THE ENERGY REGULATORY COMMISSION FOR SUPPLY OF ELECTRICAL ENERGY BY THE KENYA POWER AND LIGHTING COMPANY LIMITED PURSUANT TO SECTIONS 6 AND 45 OF THE ENERGY ACT, 2006

NOTICE is given that pursuant to section 6 (i) and section 45 of the Energy Act, 2006, the Energy Regulatory Commission has amended the Schedule of Tariffs, prescribing the Tariffs, Charges, Prices and Rates to be charged by The Kenya Power and Lighting Company Limited to the Consumers for electrical energy who are within the categories listed below:

METHOD DC1-LIFELINE: Applicable to Domestic Consumers for supply provided and metered by the Company at 240 or 415 volts and whose consumption does not exceed 100 Units per Post-paid Billing Period or Pre-paid Units Purchase Period.

(a) Energy charges of KSh. 10.00 per Unit for Units consumed;

METHOD DC2-ORDINARY: Applicable to Domestic Consumers for supply provided and metered by the Company at 240 or 415 volts and whose consumption is greater than 100 units but does not exceed 15,000 Units per Post-paid Billing Period or Pre-paid Units Purchase Period.

(a) Energy charges of KSh. 15.80 per Unit for Units consumed:

METHOD SC1: Applicable to non-domestic Small Commercial Consumers for supply provided and metered by the Company at 240 or 415 volts and whose consumption does not exceed 100 Units per Post-paid Billing Period or Pre-paid Units Purchase Period.

(a) Energy charges of KSh. 10.00 per Unit for all Units consumed.

METHOD SC2: Applicable to non-domestic Small Commercial Consumers for supply provided and metered by the Company at 240 or 415 volts and whose consumption is greater than 100 units but does not exceed 15,000 Units does per Post-paid Billing Period or Pre-paid Units Purchase Period.

(a) Energy charges of KSh. 15.60 per Unit for all Units consumed.

These Charges, Tariffs, Prices and Rates are effective 1st November, 2018.

Apart from the above changes, all the other information and details as contained in Schedule of Tariffs, 2018 under Gazette Notice No. 8043 of 3rd August, 2018 remain the same.

It is drawn to the attention of the persons whose names appear in the above Schedule and to the general public the provisions of sections 30 (4) and (5) and section 23 (2) of the Teachers Service Commission Act which provide:

- (a) Where the name of any teacher is removed from the register under this Act, such name shall not be reinstated except by direction of the Commission.
- (b) A teacher whose name has been removed from the register shall cease to be a teacher for purposes of this Act with effect from the date of such removal.
- (c) A person shall not engage in the teaching service unless such a person is registered as a teacher under this Act.

Further to the provisions of the TSC Act, Regulation 18 (1) (c) (d) of the Code of Regulations for Teachers as read together with section 45 of the Teachers Service Commission Act, provides that any person who:

- (d) Not being a teacher under the Act teaches or assists in teaching in any school.
- (e) Suffers or permits or employs in any school a person not being a registered teacher shall be guilty of an offence and liable to a fine of not less than one hundred thousand shillings or to imprisonment for a term not exceeding two years or to both.
