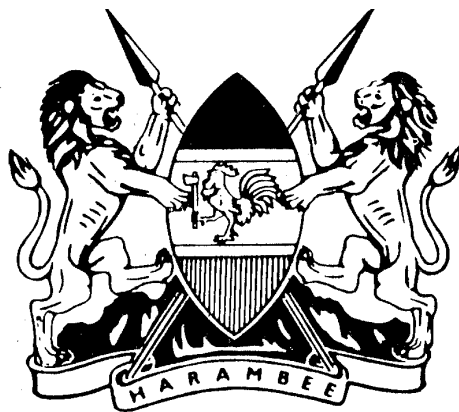

APPOINTMENT OF THE WORK PERMIT VETTING COMMITTEE FOR THE TOURISM AND HOSPITALITY SECTOR

IT IS notified for the general information of the public that the Cabinet Secretary for Tourism and Wildlife has appointed the Work

Permit Vetting Committee for the Tourism and Hospitality Sector, to vet expatriates seeking employment in the Sector in Kenya which shall comprise of:

The Principal Secretary for Tourism—*Chairperson*

Members:

- A representative of the State Department of Tourism
- A representative of the State Department of Immigration
- A representative of the Tourism Fund
- A representative of the Kenya Hotel Owners and Catering Association
- A representative of the Kenya Association of Tour Operators

Secretariat:

- Four (4) representatives from the State Department of Tourism
- One representative from the Tourism Fund

1. The Terms of Reference of the Vetting Committee shall be to—

- (a) vet and recommend expatriates seeking employment in the tourism and hospitality sector;
 - (b) encourage foreign exchange programs for Kenyans and vice versa for exposure with the expatriates;
 - (c) ensure that employers in the tourism and hospitality sector have submitted up-to-date returns on expatriates employed by their respective establishments;
 - (d) with respect to any vacancy other than a vacancy reserved for an investor in the tourism and hospitality sector to protect the investor’s interests, ensure that employers have made all reasonable efforts to employ Kenyans without success;
 - (e) ensure that applicants seeking work permits for employment in the tourism and hospitality sector possess unique competencies, qualifications and skills that are not available in Kenya;
 - (f) ensure that employers have identified suitable qualified Kenyans to undergo the necessary training or to understudy the expatriates with the aim of taking over the position occupied by the expatriate within the period specified in the guidelines and criteria;
 - (g) exercise any due diligence necessary to ensure compliance of the vetting requirements by all parties; and
 - (h) any other function as may be directed in writing by the Cabinet Secretary.
2. For the purpose of performing its functions, the Committee—
- (a) shall hold its meetings once in each month at such places and at such times as the Committee shall consider favourable;
 - (b) may co-opt such other persons as it considers necessary for the performance of its functions; and
 - (c) shall, subject to the Act, regulate its own procedure.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
