1. The Terms of Reference of the Taskforce shall be:

(a) Undertake a comprehensive analysis in the country to identify vulnerable persons in need of relief assistance.

(b) Identify agencies, actors and partners currently involved in provision of relief assistance and their mode of operation.

(c) Examine existing laws, policies, regulations and guidelines on social protection and in particular those related to the provision of relief assistance, and identify any existing gaps.

(d) Map out the existing systems of cash transfer and establish how they could be linked to the proposed digitalization of relief food assistance.

(e) Harmonize various relief intervention programmes to create a common platform.

(f) Review existing systems for monitoring shocks that affect the vulnerable in the society.

(g) Assess existing financial providers and determine the most appropriate for provision of relief assistance.

(h) Design a suitable digital platform for provision of relief assistance.

(i) Undertake a review of existing structures for co-ordination of relief programmes at the county level and their linkages with the National government structures.

(j) Review existing regulatory and institutional legal framework for co-ordination of relief assistance.

2. The Joint Secretaries of the Taskforce shall:

(a) Be responsible for the official communication of the Taskforce.

(b) Keep custody of all records and documents generated within the lifetime of the Taskforce.

(c) Co-ordinate all operational activities of the Taskforce.

3. In the performance of its functions, the Taskforce shall:

(a) Regulate its own procedures.

(b) Form technical/working groups as may be necessary.

(c) Co-ordinate an all-inclusive stakeholders consultative process at all levels.

(d) Identify and co-opt technical experts or any other necessary resource persons provided that the co-opt members do not exceed one-third of the membership of the Taskforce

(e) With the approval of the Principal Secretary in the State Department for Devolution, engage the services of such consultants as may be necessary for the performance of its mandate.

(f) Call for any relevant documents and information in the possession, custody or control of any relevant institution or person.

(g) Solicit, receive and consider views of the members of the public and interested groups in promoting public participation for the achievement of the objectives set out in paragraph 1 above.

4. The term of the Taskforce shall be thirty (30) days from the date of the publication of this notice.

5. The costs incurred by the Taskforce, Joint Secretaries and the Secretariat shall be defrayed from the voted funds of the Ministry or development partners.

6. The Taskforce shall make periodic reports to the Cabinet Secretary and will submit its final comprehensive report at the end of its tenure as provided under paragraph 4 above

7. On request of the Taskforce and before the expiry of the period provided under paragraph 4, the Cabinet secretary may extend the tenure of the Taskforce but such extension shall not exceed thirty (30) days

8. The Secretariat of the Taskforce shall be based at the Headquarters of the State Department for Devolution.

Mandate

The mandate of the Committee is to investigate alleged acts of gross misconduct and incompetence against the officer who has been interdicted to facilitate investigations and appropriate actions.

The Terms of Reference (TOR) of the Committee are to:

- Study various documents including legislation, policies, rules, regulations, warning and interdiction letters among others that may assist the team in its investigations;
- Study and categorize as appropriate the alleged acts of gross misconduct against the officer and issues for investigation;
- Receive, study and analyze information relating to alleged acts of misconduct against the officer;
- Interview relevant public officers, contractors, suppliers and members of the public who may have information on the alleged acts of gross misconduct;
- Collect and clearly record all relevant material facts pertaining to the alleged acts of gross misconduct;
- Investigate and establish whether the alleged acts of gross misconduct for each of the officers have been proven or not giving reasons thereof; and
- Prepare a well written report with clear findings backed by relevant evidence within the specified timeframes and submit the same to the Governor, Vihiga County.

Powers of the Committee

In the performance of its functions, the Committee will have all the powers necessary to:

- (a) Review reports and literature that may inform it on its mandate;
- (b) Have access to all reports and documents necessary for the effective discharge of its mandate;
- (c) Hold private hearings whenever it becomes necessary to instill confidence in the people appearing before the committee to allay their fears of adversity or reprisals;
- (d) Receive written memoranda from individuals and groups on all issues relevant to its mandate;
- (e) Have access to all reports and documents necessary for the effective discharge of its mandate;
- (f) To summon any one person deemed to hold relevant information in the course of this inquiry; and
- (g) To seek clarification from any institution in line with the mandate.

Complementary Information and Requirements:

The following complementary information and requirements for the assignment shall apply:

- (a) The Committee is required to prepare and present their Concept Note including clear interpretation of the terms of reference and a detailed programme of work and submit same to the Ag. County Secretary within one (1) week of their appointment;
- (b) The County Government will, through the Office of the Acting County Secretary, facilitate the work of the Committee including providing them with an office from where they will operate as well as normal office secretarial services and logistical support;
- (c) The Investigations Committee may request the County Government of Vihiga to seek the services of any specialist deemed necessary to provide support to the Committee in their work;
- (d) The Investigations Report shall be submitted within twenty-one (21) days from the date of this appointment.
- (e) The Team may, if deemed necessary, split into smaller groups or organize themselves in other appropriate ways to enable them to undertake the work expeditiously.
- (f) Remuneration rates for the Committee will be as stated in a separate letter on payable remuneration which will be computed on the basis of signed and documented attendance of scheduled meetings and satisfactory completion and delivery of specified outputs relating to the assignment and programme of work, among others.

2.0 Scope of the Report:

This report covers the extent to which the values and principles as enshrined in Articles 10 and 232 of the Constitution of Kenya, 2010 were embedded in Board decisions and policies with a view of translating these values into practice.

3.0 Measures/Steps Taken in Realization of National Values and Principles of the Public Service

- (a) The Board undertook induction training on Values and Principles of Public Service for newly engaged staff.
- (b) During the year, the board inducted Six Hundred and Seventy Two (672) Interns on Values and Principles of Public Service at Chebororwa Agricultural Training Centre.

- (i) On promotion of values and principles of public service, the Board enhanced collaborations with stakeholders including EACC, Ministry of Public Service, Gender and Youth, Salaries and Remuneration Commission and Public Service Commission through continuous engagement on issues pertaining to management of Human Resource in the County.
- (j) The recruitment process as undertaken by the Board affords equal opportunity to all and encourages Women, Youth, Persons with Disabilities and the marginalized to apply. - (4) *Act Supplement* contains Acts passed by the National Assembly, Senate or County Assemblies.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the Notice is, each page being numbered and should be typed with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to Notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 34. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
