#### THE CONSTITUTION OF KENYA

## THE NATIONAL ASSEMBLY STANDING ORDERS

CANCELLATION OF THE SPECIAL SITTINGS OF THE NATIONAL ASSEMBLY

PURSUANT to Article 126 (1) of the Constitution, the National Assembly approved its calendar for the fourth session on the 18th February, 2020;

Whereas on the 17th March, 2020, the Assembly amended the calendar and resolved to proceed on recess and resume on the 14th April, 2020 in light of the COVID-19 Pandemic;

Whereas pursuant to Standing Order 29 (1), the Leader of Majority Party of the Assembly requested for Special Sittings of the Assembly for purposes of considering measures seeking to cushion the public from the economic effects of the COVID-19 Pandemic;

And Whereas the Special Sittings of the Assembly were subsequently notified *vide* Gazette Notice No. 2793 and scheduled to be held on Wednesday, 8th April, 2020;

Further Whereas the advice of the Ministry of Health requires the need to observe stricter health measures that ensures the safety of the Members of the National Assembly, the staff of the National Assembly and the public;

And Whereas the health measures announced by the Government makes it untenable for the Assembly to hold the special sittings scheduled for Wednesday, 8th April, 2020;

Whereas there is need for the Assembly to continue discharging its functions in particular through the consideration of the measures geared towards cushioning the public from the economic effects of COVID-19 Pandemic;

Further Whereas the COVID-19 pandemic continues to pose challenges in the manner in which the Assembly conducts and consider its business, the leadership of the Assembly is in the meantime exploring ways of facilitating the Sittings of the House including remotely by use of modern technology;

Now Therefore-

(i) pursuant to Standing Order 1 of the National Assembly Standing Orders, it is hereby notified for the information of the Members of the National Assembly and the general public that the Special Sittings of the Assembly that were scheduled to be held on Wednesday, 8th April, 2020 are

- cancelled and the Gazette Notice No. 2793 of 2020 is accordingly revoked;
- (ii) the calendar of the House as approved on 18th February, 2020 and amended on 17th March, 2020 remains in force, unless amended or varied by the Assembly; and,
- (iii) the next sitting of the National Assembly will be held on Tuesday, 14th April, 2020, commencing at 2.30 pm.
