THE PROTECTED AREAS ORDER, 2020

IN EXERCISE of the powers conferred by section 3(1) of the Protected Areas Act, the Cabinet Secretary for Interior and Co-ordination of National Government makes the following order:

THE DANDORA WASTE WATER TREATMENT PLANT (RUAD), PROTECTED AREA ORDER, 2020

1. This Order may be cited as the Protected Area Order, 2020.
2. The areas, places or premises described in the schedule is/are declared to be protected areas for purposes of the Act and no person shall be in the specified areas without permission of the prescribed Authority or the Cabinet Secretary for Water & Sanitation and Irrigation.
3. For the purposes of this Order, the prescribed authority shall be the Managing Director, Nairobi Water and Sewerage Company Limited.
