## 1. Terms of Reference

The Terms of Reference of the Taskforce are to—

- (a) review the Kenya Media Policy Guidelines, 2009 contained in Gazette Notice No. 12071 of 2009;
- (b) identify any gaps or inconsistencies in the Kenya Media Policy Guidelines, 2009 and propose specific policy and legislative review requirements;
- (c) develop reviewed draft Kenya Media Policy Guidelines;
- (d) perform any other task related to the foregoing

## 2. Powers of the Taskforce

The Taskforce shall have power to—

- (a) regulate its own procedure;
- (b) hold meetings, public forums or consultations as it shall deem necessary in such places and at such times as the Taskforce shall consider necessary for the proper discharge of its mandate;
- (c) review official reports, policy, legislation or any document related to the Taskforce mandate;
- (d) hold consultative meetings with sector stakeholders and members of the public;
- (e) carry out or cause to be carried out such studies or researches as may be necessary to assist the Taskforce discharge its mandate; and
- (f) co-opt secretaries of the Taskforce and experts, in particular areas of need as may be necessary to assist the Taskforce discharge its mandate.

## 3. Duration

The term of the Taskforce shall be for a period of three (3) months from the date of publication of this notice and the Cabinet Secretary may, if necessary extend the term of the Taskforce.

## 4. Deliverables

The Taskforce shall prepare and submit to the Cabinet Secretary—

- (a) a work-plan and progress reports;
- (b) reviewed Kenya Media Policy Guidelines.

## 5. Secretariat
