- (i) Sensitize stakeholders and the public on the criminal justice reforms.

2. In the discharge of its mandate, the Committee may, on temporary basis, identify and invite relevant technical expert(s) on a specific issue or agenda.

3. The Committee shall report to and update the NCAJ Council on its progress every quarter.
