REPORT ON THE AFFAIRS OF THE ASSUMPTION OF THE OFFICE OF COUNTY GOVERNOR COMMITTEE – SEPTEMBER 2022

INTRODUCTION

The Assumption of the Office of Governor Act, 2019 is an Act of Parliament that provides for the procedure and ceremony for the assumption of the Office of Governor-elect; and for connected purposes.

The Act requires that each County establishes the Assumption of the Office of County Governor Committee, which is an ad hoc

committee. Pursuant to section 5 (1) of the Act, the County Government of Kiambu established the Assumption of the Office of County Governor Committee. Section 18 of the Act requires that the committee prepare a report on its affairs within a period of one month from the date of the swearing-in of the County Governor-elect, submit the same to the County Assembly and publish the report in the Gazette.

Membership of the Assumption of the Office of County Governor Committee

The membership of the Assumption of the Office of County Governor Committee as per section 5(2) comprised of—

- (a) the County Secretary who shall be the Chairperson;
- (b) the officer in-charge of legal matters in the county;
- (c) the Chief Officer in the Department responsible for matters relating to county public service;
- (d) the Chief Officer in the Department responsible for matters relating to information and communication;
- (e) the Chief Officer in the Department responsible for matters relating to Finance;
- (f) the Chief Officer in the Department responsible for matters relating to culture and social services;
- (g) a representative of the Ministry responsible for matters related to devolution;
- (h) the County Commissioner;
- (i) a representative of the National Intelligence Service at the county level;
- (j) a representative of the National Police Service at the county level:
- (k) the Clerk of the county assembly;
- (1) a representative of the Judiciary at the county level; and
- (m) two persons, one man and one woman nominated by the Governor-elect

Section 5 (3) of the Act states that the Chief Officer in the Department responsible for matters relating to the county public service shall be the secretary to the Committee.

Functions and powers of the Assumption of the Office of County Governor Committee

The functions of the Assumption of the Office of County Governor Committee as per section 6 of the Act are — $\,$

- (a) to facilitate the handing over process by the outgoing Governor to the Governor-elect;
- (b) ensure and coordinate the provision of security services to the Governor-elect;
- (c) put in place the necessary facilities and deploy the necessary personnel for the Governor-elect upon assumption of office;
- (d) co-ordinate the briefings of the Governor-elect by the relevant county public officers including submission of the following information—
 - (i) an up-to-date assets register;
 - (ii) an up-to-date register of liabilities
 - (iii) a complete list of all bank accounts and reconciled balances;
 - (iv) a report of staff establishment per department;
 - a comprehensive report on county entities or corporations and agencies containing information outlined in (i) to (iv)
 - (vi) a report of all ongoing projects including donor funded
 - (vii) an up to date report on all pending legal cases; and
 - (viii) county source of funding.

- (e) facilitate communication between the outgoing Governor and the Governor-elect:
- (f) prepare the program and organize for the swearing-in ceremony;
- (g) prepare the oath and certificate of inauguration; and
- (h) carry out any other activity necessary for the performance of its functions under the Assumption of the Office of Governor Act, 2019 and perform any other function assigned to it under any other written law.

Formation of Sub-Committees

Pursuant to section 7(1) of the Act, the committee established three (3) sub-committees which were necessary for the better carrying out of its functions.

(a) Budget and Finance Sub-Committee

The sub-committee was tasked with the preparation of the budget for the assumption of the office of Governor Committee, co-ordination of the preparation of the departmental and financial reports.

(b) Co-ordination, Communication and Logistics Sub-Committee

The Sub-committee was in charge of protocol, logistics of the swearing-in ceremony, hospitality, entertainment, identification of the venue for the swearing-in ceremony, preparation of the swearing-in documents and assembling of the instruments of power.

(c) Security Sub-Committee

The sub-committee was tasked with the provision of security to the Governor-elect and the Deputy Governor-elect, provision of security and traffic control during the swearing-in ceremony

ACTIVITIES OF THE COMMITTEE

The Assumption of Office of Governor Committee and sub-committees held several meetings in preparation for the handing over process by the outgoing Governor to the Governor-elect. The deliberations and resolutions of the said meetings are contained in the minutes. Every member and staff assigned to the committee signed a confidentiality agreement in line with section 20(4) of the Assumption of the Office of Governor Act, 2019. The committee undertook the following activities.

(i) Inaugural Meeting

The Assumption of Office of County Governor Committee held its first meeting on 8th July, 2022. During this meeting, the Chairperson took the members through the Assumption of the Office of Governor Act, 2019 for them to understand their roles and responsibilities. The members developed a work plan that would guide their activities.

(ii) Co-ordination of the provision of security services to the Governor-elect and Deputy Governor-elect

Upon declaration of the final result of the Governor-elect by Independent Electoral and Boundaries Commission, the Committee through the County Commissioner provided security to the Governor-elect and Deputy Governor-elect.

(iii) Put in place the necessary facilities and personnel for the Governor-elect and Deputy Governor-elect

The Committee through the Chairperson made the necessary arrangements on office accommodation for both the Governor-elect and Deputy Governor-elect and deployed the necessary personnel.

(iv) Co-ordination of the briefings of the Governor-elect by relevant County Public Officers

The Committee through the Chairperson facilitated briefings of the Governor-elect by the County Executive, County Public Service Board and the County Assembly. The briefings were done in accordance with section 6 (1) (d) of the Assumption of the Office of Governor Act ,2019.

(v) Co-ordination of the provision of information from the County Departments pursuant to Section 6 (1) (d)

The Accounting Officers responsible for the County Departments, County Public Service Board and County Assembly provided county information as per the format provided in the Second Schedule of the Act to the Committee through the Chairperson.

The information submitted by the County Departments, County Public Service Board and the County Assembly detailed; up to date assets register, up to date register of liabilities, list of all bank accounts and reconciled balances, a report of staff establishment per department, a report on county entities or corporations and agencies, a report on all ongoing projects including donor funded projects, a report on all pending legal cases and the County source of funding.

On the County assets, the departments provided information on the assets inherited from the Defunct Local Authorities, those earmarked for transfer from National Government for devolved functions and those acquired by the County Government since 2013.

(vi) Facilitation of communication between the outgoing Governor and the Governor-elect

The Committee through the Chairperson and the County Commissioner facilitated communication between the outgoing Governor and the Governor-elect.

(vii) Swearing-in Ceremony

Prior to the swearing-in ceremony, the committee gazetted the date, the time and the venue for the swearing in ceremony vide *Gazette Notice* No. 9890. The ceremony was conducted at Kirigiti International Stadium on Thursday, 25th August, 2022 and presided over by Hon. Lady Justice Abigail Mshila and witnessed by Hon. Emily Ominde, Chief Magistrate, Kiambu Law Court.

During the ceremony, the Governor-elect and the Deputy Governor-elect took oath of office. The Governor thereafter signed the Certificate of Inauguration. Additionally, the Governor and the Deputy Governor committed to the Leadership and Integrity Code.

Pursuant to section 13(1) of the Assumption of the Office of Governor Act, 2019, the outgoing Governor handed over the instruments of power to the Governor-elect.

OBSERVATIONS OF THE COMMITTEE

The Committee noted that there was need to review the Assumption of the Office of Governor Act' 2019, to address the following noted concerns:

1. In instances where the outgoing Governor does not attend the swearing in ceremony, there is no provision for any other person to hand over the instruments of power. It is recommended that the

County Secretary and Head of Public Service being the senior most member of staff in the County and the Chairperson of the Assumption of the Office of Governor Committee be expressly empowered to handover the instruments of power.

- 2. The current Act provides for departmental reports to be prepared upon establishment of the Assumption of the Office of Governor Committee. Due to the heavy volume of work required to generate the reports, the committee proposes that the law be amended to allow the County Secretary call for preparation of the reports three (3) months before the establishment of the committee.
- 3. The committee noted that the power to make regulations under section 24 of the Act vests in the County Executive Committee Member responsible for Public Service. This being a national legislation and in order to create uniformity and standardization in the assumption of the office of Governors countrywide, this power should vest in the Cabinet Secretary responsible for Devolution.
- 4. Section 5 of the Act provides for the nomination of representatives of the Governor-elect as anticipated under Section 5(2)(m). However, subsection 5 refers to nomination made under paragraph 2 (l) (representative of the Judiciary). There is need to harmonize section 5 (5) to align with section 5 (2) (m).
- 5. There is need for clarity on the swearing-in of the Governor-elect pursuant to section 11 (2) of the Assumption of the Office of Governor Act, 2019 in view of section 39 (1) of the Elections Act, 2012 (Rev. 2016). Whereas section 39 (1) of the Elections Act requires the commission to determine, declare and publish the results of an election immediately after close of polling, section 11 (2) of the Assumption of the Office of Governor Act, 2019 omits the requirement of the gazettement of the Governor-elect before the swearing-in ceremony. There is need for an amendment of either or both of the Acts to minimize the risk of multiple interpretations.

CONCLUSION

The entire process of the Assumption of Office of the Governor in Kiambu County was successful due to the collaboration between the National Government and the County Government. This collaboration need to be embraced in all other engagements for purpose of ensuring seamless service delivery to the people of the great County of Kiambu.

The County Government of Laikipia was established pursuant to Article 174 of the Constitution of Kenya, 2010. It is located within the Rift Valley region and its headquarters is located at Rumuruti. It borders Samburu County to the North, Isiolo County to the North East, Meru County to the East, Nyeri County to the South East, Nyandarua County to the South, Nakuru County to the South

West and Baringo to the West. It covers an area of 9,532.2 sq. The County comprises three constituencies namely: Laikipia East, Laikipia North and Laikipia West.

The County Government is comprised of the Executive and the Assembly. The operations of the County Executive are structured around 8 departments headed by 8 County Executive Committee Members and 10 Chief Officers, who are both the accounting and/or the authorized officer of the department.

Establishment of the Office of the Governor Committee

The Assumption of the Office of the Governor Committee, Laikipia County was established in accordance to section 5 (1) of the Assumption of Office of the Governor Act, 2019. It was established on 8th July, 2022. The committee comprised of the following members;

ACTIVITIES OF THE COMMITTEE

The Act required the Chairperson of the Committee to convene the first meeting thirty days before the date of the general election. The committee held its inception meeting on 8th July, 2022. All members present signed the Confidentiality Agreements as provided for under the Oaths and Statutory Declaration Act and in compliance with section 20 (4) of the Act.

The committee developed its action plan and established sub committees for the better carrying out of its functions.

(a) Preparation of Reports

The Committee co-ordinated the compilation of the handing-over report and the report on the affairs of the Committee.

(b) Swearing-in Ceremony

The swearing-in of H.E. Joshua Wakahora Irungu and H.E. Reuben Kamuri Ngatia as the Governor and Deputy-Governor of Laikipia County, respectively, was held at Nanyuki Stadium, on Thursday, the 25th August, 2022, from 10.00 a.m. to 2.00 p.m.

The ceremony was presided over by Hon. Lady Justice Florence Muchemi and moderated by Hon. Kithinji Rwito, the Chief Magistrate, Nanyuki Law Courts.

Prior, the Committee had notified the general public of the date, time and venue of the swearing-in ceremony *vide Kenya Gazette* notice number 9872, dated 17th August, 2022.

The following are the key highlights of the Swearing-in Ceremony:

- (1) The Governor-elect and Deputy Governor-elect took and subscribed to the Oath of Office as prescribed in the First Schedule of the Act. The Governor-elect also signed a certificate of inauguration.
- (2) Upon taking the Oath of Office, the Governor and Deputy Governor also signed the Leadership and Integrity Code for State Officers pursuant to section 40 of the Leadership and Integrity Act as read together with Regulation 34 (2) of the Leadership and Integrity Regulations, 2015, Laws of Kenya.
- (3) The outgoing governor handed over the instrument of power to the County Governor-elect.
 - (4) The Governor gave his speech.

(a) County General Information

Uasin Gishu County (No. 27) is one of the 47 counties that were formed pursuant to Article 174 of the Constitution of Kenya, 2010. It is located within the North Rift Valley region and its headquarters is located at Eldoret town. It extends between longitude 34o 50' East and 35o 37' West; latitude 00 03' South and 0o 55' North and has a high altitude of 2164.67m (7101.94ft). It borders Trans Nzoia County to the North, Elgeyo Marakwet County to the East, Baringo County to the South East, Kericho County to the South, Nandi County to the South West and Kakamega County to the North West. It covers a total of 3.345.2 km2.

Soy, Turbo, Moiben, Ainabkoi, Kapseret, and Kesses administratively form the 6 sub-counties and also are demarcated as constituencies under the Independent Electoral and Boundaries Commission. The sub-counties are further delimited into 30 wards, 57 locations and 105 sub-locations.

Kenya National Bureau of Statistics Population and Housing Census, 2019 as published, indicated the population of the county as 1,163,186 with 580,269 being male and 582,889 being female. The inter-censal population growth rate for the county is 3.6 percent which is slightly higher than the national rate of 2.9 percent.

(b) The Structure of the County Government

The County Government is comprised of the County Executive and County Assembly. The Governor and the Speaker heads the Executive and the County Assembly, respectively, as per the structure below. The County Executive has ten departments headed by the County Executive Committee Members and respective Chief Officers who are the accounting officers. In addition, the County Government has a total staff establishment of 4,203 some were seconded from National Government upon devolution of functions, staff of defunct Local Authorities, and those employed by the County Public Service Board.

Introduction

Section 5 of the Assumption of the Office of Governor Act, 2019 established The Assumption of the Office of Governor Committee tasked with, among other functions, within one month of the swearing in of the County Governor-elect, prepare a report on the affairs of the committee, submit the same to the County Assembly and publish the report in the *gazette* in accordance with section 18 of the Act.

(The Assumption of the Office of Governor Act, 2019)

Composition of the Committee

Section 5 (1) and 5 (2) of the Act, establishes and sets out an *ad hoc* committee comprised as follows—

- (a) the County Secretary who shall be the Chairperson;
- (b) the officer in charge of legal matters in the County;
- (c) the Chief Officer in the department responsible for matters relating to County Public Service;
- (d) the Chief Officer in the department responsible for matters relating to Information and Communication;
- (e) the Chief Officer in the department responsible for matters relating to Finance;
- (f) the Chief Officer in the department responsible for matters relating to Culture and Social Services;
- (g) a representative of the Ministry responsible for matters related to Devolution:
- (h) the County Commissioner;
- (i) a representative of the National Intelligence Service at the County level;

- (j) a representative of the National Police Service at the County level:
- (k) the Clerk of the County Assembly;
- (1) a representative of the Judiciary at the County level; and
- (m) two persons, one man and one woman nominated by the Governor-elect

Section 5 (3) of Act states that the Chief Officer in the department responsible for matters relating to the County Public Service shall be the Secretary to the Committee. In addition, section 5 (4) of the Act states that the members referred to in subsection 2 (h) and (i) shall be the members serving as members of the County Policing Authority established under the National Police Service Act. Section 5 (5) of the Act, the members referred to in subsection 2(1) shall be nominated upon the declaration of the final results of the election of the Governor. Section 7 (1) and (2) gives the committee powers to establish such subcommittees as may be necessary and may co-opt into sub-committee person(s) whose knowledge and skills are necessary for the effective functioning of the Committee.

Pursuant to section 5 (10), the term of office of a Committee established under this section shall lapse upon the submission of the report of the Committee to the County Assembly in accordance with Section 18 (2) of the Act.

Functions and Powers of the Committee

Section 6 (1) (a-h) of the Act, stipulates the functions of the committee as follows—

- (a) facilitate the handing over process by the outgoing Governor to the Governor-elect:
- (b) ensure and coordinate the provision of Security services to the Governor-elect:
- (c) put in place the necessary facilities and deploy the necessary personnel for the Governor-elect upon assumption of office;
- (d) co-ordinate the briefings of the Governor-elect by the relevant county public officers including submission of the following information—
 - (i) an up to date assets register;
 - (ii) an up to date register of liabilities;
 - (iii) a complete list of all bank accounts and reconciled balances;
 - (iv) a report of staff establishment per department;
 - (v) a comprehensive report on county entities or corporations and agencies containing information outlined in (i) to (iv):
 - (vi) a report of all ongoing projects including donor funded projects:
 - (vii) an up to date report on all pending legal cases; and
 - (viii) county source of funding
- (e) facilitate communication between the outgoing Governor and the Governor-elect;
- (f) prepare the programme and organize for the swearing-in ceremony;
- (g) prepare the oath and the certificate of inauguration; and
- (h) carry out any other activity necessary for the performance of its functions under this Act and perform any other function assigned to it under any other written law.

Further, section 6 (2) and (3) gives powers to the Committee necessary for the execution of its functions under the Act and any other written law. In addition, all the information to be provided during the briefings referred to under section 6 (1) (d) shall be submitted by this Committee in the form set out in the Second Schedule and shall be information for a period of up to thirty days before the date of the general elections.

Activities of the Committee

The Act required the Chairperson of the Committee to convene the first meeting thirty (30) days (9th July, 2022) before the date of the General Election (9th August, 2022). Subsequently, this Committee had its first meeting on 12th July, 2022 being the second working day after 9th July, 2022 when quorum was met. In its first meeting and in compliance with section 20 (4) of the Act, every member of the committee signed confidentiality agreement. The Committee developed its work schedule including the establishment of subcommittees and co-option of persons in accordance with section 7(1), (2) of the Act. The Committee established the following Subcommittees; Security, Technical, Logistics, and Finance and Reporting.

The committee had sixteen (16) sittings whose deliberations and resolutions are contained in the minutes.

Security Sub-Committee

The sub-committee ensured provision of adequate security to the Governor elect and the Deputy Governor elect upon declaration of results by Independent Electoral and Boundaries Commission (IEBC). The team identified and mobilized security personnel for specific roles before, during and after the swearing in ceremony. These included traffic/crowd control, general security coverage, parade by County Inspectorate Service and National Youth Service (NYS) Band entertainment. The sub-committee also guided the main committee on necessary security preparations to be undertaken. The sub-committee had six (6) sittings.

Technical Sub-Committee

The sub-committee in liaison with the Judiciary ensured that the swearing-in ceremony was conducted in accordance with the law and that all County symbols (County Flag, The Constitution of Kenya 2010, County Coat of Arms and County Public Seal), the program of inauguration ceremony, the oath of office, and the certificate of inauguration were in place. It also published the location, date, and time of the swearing-in ceremony vide Gazette Notice No. 9895 dated 15th August, 2022, The subcommittee had ten (10) sittings.

Logistics Sub-Committee

The sub-committee coordinated logistical arrangements relating to the event including publicity both in print and electronic media, sourcing of venue, necessary protocols, entertainment, mobilization, sensitization, reception and general organization of the swearing-in ceremony. The sub-committee engaged National and County Government administrative officers and other staff to provide general support to the committee. It guided the Committee on identification of appropriate venue, layout, accreditation of invited guests and sitting arrangements. The sub-committee had ten (10) sittings.

Finance and Reporting Sub-Committee

The sub-committee coordinated provision of reports by relevant county public officers to the Governor elect in accordance with sections 6 (d) of the Act, which was submitted on 22nd August, 2022 as per the template in the Second Schedule of the Act. The report contained information detailing; up-to-date assets register, an up-to-date register of liabilities, a complete list of all bank accounts and reconciled balances, a report of staff establishment per department, a comprehensive report on County entities or corporations and agencies, a report of all ongoing projects including donor funded projects, an up-to-date report on all pending legal cases and County sources of funding.

The sub-committee also coordinated preparation of the report on the affairs of the Committee in accordance with section 18 of the Act and facilitated provision of budgeted funds for utilization by the committee in its activities. The sub-committee had fifteen (15) sittings.

Swearing-in Ceremony

The swearing-in ceremony took place on 25th August, 2022 at Eldoret Sports Club being the first Thursday after the tenth day following the declaration of the final results of the election of County Governor by the IEBC. The oath of office was administered by Hon. (Prof.) Mr. Justice Joel M. Ngugi and witnessed by Hon. Denis Mikoyan, Chief Magistrate, Eldoret Commercial Court. In addition, the incoming Governor H.E. Hon. Jonathan Bii Chelilim signed the inauguration certificate and the commitment to the leadership and integrity code within stipulated time by the Act. The Deputy Governor

H.E. Hon. Eng. John Barorot, M.B.S. took the oath of office and signed commitment to the leadership and integrity code.

Thereafter, the outgoing Governor H.E. Hon. Jackson K. arap Mandago, E.G.H. handed over the instruments of power to the Governor to signify transfer of authority.

The ceremony was attended by an estimate of eight thousand (8,000) members of the public. Amongst them were Members of Parliament, Members of the Diplomatic Corps, Members of the County Assembly, Senior National and County Government officials, Members of the Judiciary, Renowned sports men and women, Business leaders, Religious leaders and Council of Elders.
