# TASKFORCE ON THE REVIEW OF MULTINATIONAL COMPANIES ENGAGEMENTS IN TEA SUB-SECTOR

#### APPOINTMENT

IT IS notified for the general information of the public that the Governor of Nandi, Stephen Sang has appointed the following persons as members of a taskforce to conduct an extensive review on the multinational companies' engagements in tea sub-sector in Nandi and in collaboration with the county governments of Kericho and Bomet, for a period of ninety (90) days, with effect from the 31st October, 2022

The Taskforce shall be comprised of the following members—

Terms of Reference

The terms of reference for the Taskforce shall be to—

- (a) review the current and emerging challenges facing the tea subsector multinationals and other stakeholders within Nandi County and make appropriate recommendations;
- (b) co-ordinate stakeholders' consultation with the multinationals and other tea sub-sector players on appropriate mechanisms to address the current and emerging challenges in the sector;
- (c) review socio-economic impacts of mechanization of tea plucking machines among the multinational tea companies in Nandi and propose appropriate mitigation measures;
- (d) establish the status of all land leases including acreages held by each multinational in Nandi;
- (e) consider the current land rent, rates and applicable fees paid by the multinationals and propose appropriate policy and legal frameworks necessary to review and increase land rates and rent paid by multinationals;
- (f) consider the role, effectiveness, and relevance of multinational tea companies in management of Tea CESS and propose appropriate legal, policy and institutional framework to collect

- and manage the CESS deducted from farmers for road maintenance:
- (g) consider the roles of different stakeholders and make appropriate recommendations on how they can collaborate amongst themselves and with the county government to develop the tea sub-sector;
- (h) prepare a joint tri-patriate report on necessary legal, policy and institutional reforms for effective engagement with multinationals in the affected counties; and
- (i) carry out such other functions as may be necessary or incidental to the foregoing.

Guidelines and Modalities of Conducting Business by the Taskforce

- 2. In the performance of its tasks, the Taskforce
  - (a) shall consult with key stakeholders in the tea sub-sector;
  - (b) shall hold such number meetings in the places and at such times as the Taskforce shall consider necessary for the proper discharge of its functions;
  - (c) shall conduct public hearings and open forums and receive views from members of the public and receive oral and written submissions from any person with relevant information;
  - (d) may co-opt any person(s) as it may consider necessary or expedient for the proper performance of its functions;
  - (e) may create committees or sub-committees to expedite the discharge of its tasks;
  - (f) may consider reports of past or on-going initiatives towards enhancing the legal, policy and institutional framework in the tea sub-sector:
  - (g) may cause to be carried out such studies or research as may inform the Taskforce on its mandate; and
  - (h) may have all powers necessary or expedient for the proper execution of its functions, including the power to regulate its own procedures.
- The Secretariat of the Taskforce shall be based at the County Headquarters.
- 4. The Taskforce shall prepare and submit to the Governor, its work plan and progress report within one (1) week of its appointment
- The costs incurred by Taskforce shall be defrayed from the voted funds of the respective County Executive offices or such grants or donations as may be secured from by the Taskforce.

# THE ELECTIONS (GENERAL) REGULATIONS, 2012

BY-ELECTIONS FOR MEMBERS OF NATIONAL ASSEMBLY, KANDARA AND GARISSA TOWNSHIP CONSTITUENCIES, MEMBER OF SENATE, ELGEYO MARAKWET COUNTY AND MEMBER FOR SHELLA WARD, LAMU COUNTY ASSEMBLY SCHEDULED TO BE HELD ON THURSDAY, 5TH JANUARY, 2023

IN EXERCISE of powers conferred by Articles 85, 88(4), 97 (1) (a), 98 (1) (a), 99, 101 (4), 103 (1) (d), 177 (1) (a), 193 and 194 (1) (d) of the Constitution of Kenya, sections 5 (1) (b), 13 (3), 16, 24, 26, 30, 32, 33, 38, 38A, 43 (5A) and 74 of the Elections Act, 2011 and Regulations 11 (4), 12 (1), 13B, 14 and 15, Parts V, VI and IX of the Election (General) Regulations, 2012, the Independent Electoral and Boundaries Commission gives

- (a) Following declaration of vacancies that occurred in the office of Members of National Assembly for Kandara and Garissa Township constituencies, Member of Senate for Elgeyo Marakwet County and Member for Shella Ward, Lamu County Assembly as confirmed by the respective Speakers vide letters dated 27th October, 2022 for Parliamentary elections and 24th October 2022 for the County Assembly election, there shall be by-elections for Members of National Assembly for Kandara and Garissa Township constituencies, Member of Senate for Elgeyo Marakwet County and Member for Shella Ward in Lamu County Assembly on Thursday, 5th January, 2023.
- (b) each political party intending to participate in the by-elections shall submit the names of the persons contesting in a party primary and the date of the party primary on or before 14th November, 2022.

- (c) A public officer who intends to contest in the by-election shall resign from public office within seven (7) days of the declaration of the vacancy by the Speaker.
- (d) The Commission shall publish, in the Gazette, the names of the persons contesting in a party primary and the date of the party primary within seven (7) days of receipt of the names of the candidates.
- (e) Candidates intending to participate in the by-elections as independent candidates shall not have been members of any political party at least three (3) months immediately before the date of the by-elections.
- (f) Political parties intending to present candidates in the by-elections shall conduct party primaries and resolve all intra-party disputes and submit the list of persons nominated to contest in the by-elections to the Commission on or before Wednesday, 30th November, 2022.
- (g) Political parties intending to present candidates in these by-elections through direct nominations shall submit the list of persons nominated to contest in the elections to the Commission on or before Wednesday, 30th November, 2022.
- (h) Candidates intending to participate in these By-Elections as independent candidates shall submit their names and symbols that they intend to use during the By-elections to the Commission on or before Monday. 14th November, 2022.
- (i) The Commission shall publish in the Gazette, the names and symbols of persons intending to contest in the by-elections as independent candidates at least fourteen (14) days before the nomination day.
- (j) The days for the nomination of political party candidates and independent candidates for the by-elections shall be on Monday, 5th December, 2022 and Tuesday, 6th December, 2022 and the nomination papers shall be delivered by the candidates to the respective Returning Officers between the hours of eight o'clock in the morning and one o'clock in the afternoon and between the hours of two o'clock and four o'clock in the afternoon at the place designated by the Commission.
- (k) Disputes relating to or arising from nominations shall be determined within ten (10) days of the lodging of the dispute with the Commission in any event not later than Thursday, 15th December, 2022.
- (1) The campaign period for purposes of the Thursday, 5th January, 2023 By-elections shall commence upon nomination of the candidate on Monday, 5th December, 2022 and cease on Monday, 2nd January, 2023 being 48 hours before the by-election day.
- (m) The campaign time shall run from 7.00 a.m. to 6.00 p.m. during the campaign period.
- (n) Political parties and independent candidates shall appoint and submit to the Commission the names of their Polling Station, Constituency and County Agents to the Commission on or before Wednesday, 21st December, 2022.
- (o) The registration and revision of the register of voters for the said electoral area remains suspended.
- (p) If the elections are contested, the poll will take place on Thursday, 5th January, 2023.

#### NOTES:

- The attention of candidates and persons subscribing nomination papers is drawn to the provisions of Parts III, V, VI, VIII and IX of the Election (General) Regulations, section 13 (2) and the First Schedule to the Leadership and Integrity Act, 2012 and Chapter Six of the Constitution of Kenya.
- Every political party, candidate and every person who participates in the election shall subscribe to and observe the Electoral Code of Conduct set out in the Second Schedule to the Elections Act, 2011.
- A person guilty of an election offence will be liable to the penalties imposed by the Election Offences Act, 2016 (No.37 of 2016), the disqualifications imposed thereof and the Constitution of Kenya.
- 4. The attention of candidates and political parties is drawn to the provisions of Section 43 (5A) of the Elections Act, 2011.
- 5. The attention of candidates is drawn to the provisions of section 26 of the Elections Act, 2011.
- 6. The attention of political parties, candidates and every person who participates in the election is drawn to section 2 of the Elections Act, 2011 on the campaign period.
