ADDENDUM TO THE ADVERTISEMENT PUBLISHED ON 7TH MARCH, 2023

WHEREAS Articles 88, 166(3) and 250 of the Constitution of Kenya, 2010, sections 5 and 6 of the Independent Electoral and Boundaries Commission Act, 2011 (referred to as the IEBC Act) and the First Schedule thereto, provides for the membership of the Independent Electoral and Boundaries Commission (IEBC) and the process of appointment of the Chairperson and Members of the IEBC;

AND WHEREAS by a Gazette Notice No. 1901 of 14th February, 2023, His Excellency the President declared one (1) vacancy for the position of the Chairperson of the IEBC and five (5) vacancies for the position of Member of the IEBC;

AND WHEREAS by a Gazette No. 2643 of 1st March, 2023, His Excellency the President declared one (1) vacancy for the position of Member of the IEBC;

FURTHER WHEREAS, His Excellency the President extended the mandate of the Selection Panel for the Recruitment of Nominees for Appointment as Chairperson and Members of the Independent Electoral and Boundaries Commission to recruit the nominee for the sixth vacancy, *vide* Gazette Notice No. 3138 of 2023 dated 10th March, 2023;

NOTING, that the Selection Panel for the Recruitment of Nominees for Appointment as Chairperson and Members of the Independent Electoral and Boundaries Commission on 7th March, 2023 published an advertisement in the Kenya Gazette, the newspapers and on the website of the Parliamentary Service Commission, calling for applications for the vacancies in the positions of Chairperson and members of the Independent Electoral and Boundaries Commission;

NOW THEREFORE AND PURSUANT to Gazette Notice No. 2641 of 27th February, 2023, the Selection Panel for the Recruitment of Nominees for Appointment as Chairperson and Members of the Independent Electoral and Boundaries Commission notifies the public of the adjustment of the number of members of the Commission being recruited from five (5) members to six (6) members and the Chairperson.

MEMBER OF THE IEBC (Ref. SP/IEBC/2/2023)—6 VACANCIES

For the avoidance of doubt, applications are invited from qualified persons who satisfy the provisions of the Constitution, and section 6(2) of the IEBC Act which provide that for appointment as a Member of the IEBC, a person must—

- (a) hold a degree from a recognized university;
- (b) have proven relevant experience in any of the following —
 - (i) electoral matters;
 - (ii) management;
 - (iii) finance;
 - (iv) governance;
 - (v) public administration; or
 - (vi) law; and
- (c) meet the requirements of Chapter Six of the Constitution.

FURTHER, pursuant to Article 88 (2) of the Constitution, a person shall be disqualified for appointment as a Member of the IEBC, if the person—

- (a) has at any time within the preceding five years, held office, or stood for election as a Member of Parliament or County Assembly or has been a member of the governing body of a political party; or
- (b) holds any State Office.

Application Process

- (a) Applicants should attach—
 - (i) A cover letter;
 - (ii) A certified copy of their National Identity Card or Passport;
 - (iii) Curriculum Vitae;
 - (iv) Academic and professional certificates; and
 - (v) Any other supporting documents and testimonials.
- (b) Applicants shall be required to attach to their applications current and valid clearances from the following bodies:
 - (i) Kenya Revenue Authority;
 - (ii) Higher Education Loans Board;
 - (iii) Credit Reference Bureau;
 - (iv) Directorate of Criminal Investigations; and
 - (v) Ethics and Anti-Corruption Commission.
- (c) Applications should be addressed to:
