#### THE PENDING BILLS VERIFICATION COMMITTEE

#### APPOINTMENT

IT IS notified for general information of the public that the Cabinet Secretary for the National Treasury and Economic Planning has constituted a committee to be known as the Pending Bills Verification Committee (hereinafter referred to as "the Committee").

#### 1. Membership

The Committee shall comprise of the following members-

#### 2. Functions of the Committee

The functions of the Committee shall be to-

- (a) scrutinise and analyse the existing National Government pending bills that have accumulated between June, 2005 and June, 2022 and make recommendations to the Government on settlement of the same;
- (b) establish a clearly defined criteria for detailed examination and analysis of such pending bills or claims with a view to determining the genuineness of each or otherwise;
- (c) make recommendations to the National Treasury on the necessary actions to be taken for satisfactory disposal or settlement of the identified pending bill or claim;
- (d) identify any cases where there may have been corrupt, fraudulent and false claims against the Government and make appropriate recommendations to the relevant Government agencies;
- (e) develop reforms or measures that will ensure future accumulation of pending bills is avoided; and
- (f) perform any other function incidental to the foregoing.
- 3. Powers of the Committee
  - In the execution of its mandate, the Committee shall-
  - (a) have access to any previous reports relevant to its mandate;
  - (b) regulate its own procedures with respect to the orderly conduct of its proceedings, quorum for the transaction of business and other related matters;
  - (c) carry out or cause to be carried out such studies or research as is necessary in furtherance of its mandate; and
  - (d) in consultation with the Cabinet Secretary for the National Treasury and Economic Planning, co-opt any person as may be necessary to assist the Committee to discharge its mandate.

#### 4. Declaration of no-conflict of interest

The Chaiperson and other members of the Committee shall, prior to embarking on their duties, subscribe to the Declaration set out in the Schedule hereto.

#### 5. Deliverables of the Committee

The Committee shall prepare and submit to the Cabinet Secretary to the National Treasury and Economic Planning—

- (a) within three months after the date of its gazettement, an interim report recommending to the National Treasury settlement or otherwise of pending bills that have been scrutinised;
- (b) quarterly reports of its activities through the Principal Secretary to the National-Treasury;
- (c) within twelve (12) months after the date of its gazettement, submit a final report; and
- (d) such other reports as the Committee may consider necessary.
- 6. Secretariat of the Committee
  - (a) the National Treasury and Economic Planning shall provide secretariat services to the Committee.
  - (b) the Secretariat of the Committee shall be responsible for—
    - (i) providing appropriate background briefing to the Committee;
    - (ii) preparing the Committee's reports and disseminating any information deemed relevant by the Committee; and
    - (iii) undertaking research and liaising with relevant Government agencies or departments and any other institution for purposes of collecting relevant information necessary in furtherance of the Committee's mandate.
