REGULATORY IMPACT STATEMENT AND PUBLIC PARTICIPATION

PURSUANT TO section 8 of the Statutory Instruments Act, 2013, the Cabinet Secretary for Lands, Public Works, Housing and Urban Development, notifies the general public that a Regulatory Impact Statement on the proposed land-sector legislations consisting of the Survey (Amendment) Regulations, 2023, the Land Registration (General) (Amendment) Regulations, 2023, the Land Adjudication (Amendment) Regulations, 2023, the Community Land (Amendment) Regulations, 2023, the Physical and Land Use Planning (Planning Fees) (Amendment) Regulations, 2023, the Valuers (Forms and Fees) (Amendment) Rules, 2023, and the Land Registration (Amendment) Regulations, 2023, has been prepared to assess the impact of the statutory instruments on the community and businesses.

The main objective of the proposed statutory instruments is to amend the existing statutory instruments that have not been updated for a long time, especially in respect of fees and charges prescribed for various services rendered by the Government in the land sector. Some of the fees prescribed by the statutory instruments have remained unchanged for thirty years occasioning the need to balance service-delivery and the cost of providing services. The following is a summary of what the Regulations seek to provide for-

- (a) to strike a balance between services rendered by the Government and the cost of the services;
- (b) to cost services that have hitherto never been costed;
- (c) to enhance service delivery by balancing service and cost of service, hence affordability of the Government to offer the services;
- (d) to bring equity to different service seekers by bringing all the statutory instruments into harmony with each other;
- (e) to eliminate fees and charges for services hitherto provided that have become obsolete; and
- (f) to enable the Government to employ innovation and technology in the delivery of services.

This is, therefore, to request all persons who are likely to be affected by the proposed statutory instruments to submit written memoranda on the proposed statutory instruments, to reach the undersigned within fourteen (14) days from the date of the publication of this notice.

The draft Regulatory Impact Statement and the proposed statutory instruments are available on the Ministry's website (<https://lands.go.ke>). The draft Regulatory Impact Statement and the proposed statutory instruments are also available on request through the Ministry's email address (leviesregulations@gmail.com) during normal working hours. Members of the public are also invited to tender their representations and comments and send them through the postal and physical addresses provided in this notice or through the Ministry's email address.
