CORRIGENDUM

General Notice No 1804 of 2016 published in the Government Gazette dated 3 December 2016 should be amended as follows:

- (i) Page 4, third bullet, the definition of 'a public interest entity' should be replaced by:
 - Any company which has, during 2 consecutive preceding years, at least one of the following:
 - o an annual turnover exceeding 500 million rupees; or
 - o total assets exceeding 500 million rupees.
 - Any group company which has, during 2 consecutive preceding years, at least one of the following:
 - o an annual turnover exceeding 1 billion rupees; or
 - o total assets exceeding 1 billion rupees.

(ii) Page 39, last paragraph of 'The Audit Committee and the Auditors', to read as follows:

'If applicable and subject to relevant laws or other regulatory requirements, the auditor should be reappointed every year at the annual meeting and the Board should consider putting the external audit contract out to tender at least every 7 years'.

(iii) Page 61, first line to be replaced by:

'The Ministry of Financial Services, Good Governance and Institutional Reforms was established in 2014';

(iv) **Page 70**, the last paragraph (d) 'Assessment' should read as follows:

'The Board will put the external audit contract out to tender at least every 7 years and consider whether the audit partner should be rotated at least every 5 years'; and

(v) Page 104, second line in paragraph Insurance read as follows:

'The current indemnity limit is Rs [amount]; a copy of the policy document is attached'.
