POLICE NOTICE

CAVADEE AND “MARCHE SUR LE FEU” CEREMONY AT THE ARUL MIGOU KANNANUR MARIAMMEN KOVIL – NO. 1, RENGAYA IYER STREET (Ex. Farquhar) – PORT LOUIS

By virtue of authority conferred upon me by Section 25(3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made as **from Friday 23rd February, 2018 to Monday 05th March, 2018** for the above mentioned ceremony.

2. Closed Roads as from 18.30 Hours

The following roads will be closed for vehicular traffic as hereunder:-

- (a) Sir Edgar Laurent Street with its junction with Royal Street near Total Filling Station will be closed for vehicular traffic;
- (b) All along Rengaya Iyer Street (Ex. Farquhar) with its junction with the New Trunk Road near St Antoine Church up to Dr. Yat Sen Street will be closed for vehicular traffic;
- (c) Etienne Pellereau street with its junction with David Street up to the Temple will be closed for vehicular traffic;
- (d) Renganaden Seeneevassen street (La Paix) along the stretch from the junction with David street up to the Temple; and
- (e) All lateral roads in connection with Farquhar Street from New Trunk Rad near St Antoine Church up Dr. Sun Yat Sen Street will be closed for vehicular traffic.

3. Diversion of Traffic

Vehicular traffic will be diverted as hereunder:-

- (a) Vehicular traffic coming from Khadafi Square, Plaine Verte along Sir Edgar Laurent Street, Plaine Verte will be diverted onto Noor-E-Islam Street, Port Louis near Royal Gate via Military Road near CEB Sub Station – Pump Round About near ABC Motors – Quay “D” Round About – New Trunk Road to proceed to the South; and
- (b) Vehicular traffic coming from Ste Croix along Nicolay Road will be diverted onto Madad Ul Islam Street, Plaine Verte to proceed to the South.

4. Buses

Buses coming from Khadafi Equare, Plaine Verte along Sir Edgar Laurent Street, Plaine Verte will be diverted onto Noor-E-Islam Street, Port Louis near Royal Gate via Military Road near CEB Sub Station – Pump Round About near ABC Motors – Quay “D” Round About – New Trunk Road to proceed to reach the Immigration Bus Stand.

5. Pedestrian Zone

All along Rengaya Iyer Street (Ex. Farquhar), from New Trunk Road near St Antoine Church up to Dr. Sun Yat Sen Street, Port Louis will be declared as a Pedestrian Zone.

6. Judicial Proceeding

Non compliance with these traffic arrangements will entail judicial proceedings.
