**NOTICE OF ELECTION OF SEVEN MEMBERS OF
THE DENTAL COUNCIL OF MAURITIUS**

Notice is hereby given to all fully registered dental surgeons and dental specialists that the election of seven members of the Dental Council of Mauritius (comprising two members from the public service and five members from the private sector) will be conducted by the Office of the Electoral Commissioner on the fourth (4th) day of August 2018; and that the Returning Officer will receive the nomination of candidates for the said election on **Saturday the fourteenth (14th) day of July, 2018**, next ensuing, between the hours of **9 am** and **12 noon** at the seat of the Dental Council of Mauritius, One Way Floreal Road, Cité Mangalkhan, Floreal.

Forms of nomination papers may be obtained **either** from the Registrar, at the seat of the Dental Council of Mauritius at the abovementioned address **or** from the Health Director, Queen Elizabeth Hospital, Creve Coeur, Rodrigues, between the hours of 9 am and 3 pm on working days (excluding Saturdays).

Every nomination paper must be signed by **five** fully registered dental surgeons or dental specialists and be delivered to the Returning Officer between the said hours of 9 am and 12 noon on **14th July, 2018**.

Every nomination paper shall specify the name, address and date of registration of the candidate and also contain a declaration by the candidate that:-

- (a) on nomination day he is a fully registered dental surgeon or dental specialist and is not otherwise suspended;
- (b) on nomination day he reckons at least **10 years'** experience as dental surgeon or dental specialist in the Republic of Mauritius; and
- (c) he is a citizen of the Republic of Mauritius.

Nomination Papers received by post, fax, email or otherwise will not be considered.
