In virtue of Section 25(3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made on Saturday 8th and Sunday 9th September 2018 in Metropolitan (North) Division on the occasion of "Father Laval Pilgrimage".

2. Closed Street

The following streets will be closed to vehicular traffic and declared as pedestrian zone except in cases of emergency:-

(a) On 08.09.18 as from 12.00 hours to 06.00 hours on 09.09.2018

Allée Père Laval from its junction with Pamplemousses Road up to Père Laval Church.

(b) On 08.09.18 as from 16.00 hours to 06.00 hours on 09.09.2018 or as and when decided by Police

(i) Pamplemousses Road from its junction with Riche Terre Branch Road up to that with Ducray Street, Ste Croix;

(ii) Nicolay Road, Ste Croix and lateral roads from Abercrombie Round About up to its junction with Military Road near British American Tobacco (BAT);

(iii) Ste Marie Road, Ste Croix and lateral roads from its junction with Le Cornu Street up to Piston Père Laval Street;

(iv) Pieton Père Laval and lateral roads from its junction from Pamplemousses Road Ste Croix up to Père Laval Church;

(v) Ducray Street, Ste Croix and lateral roads from its junction from Pamplemousses Road, Ste Croix up to Nicolay Road; and

(vi) Cocoterie Road, Ste Croix and lateral roads from its junction from Nicolay Road up to Ste Famille Street, Ste Croix.

3. ONE-WAY STREET - on 08.09.2018 as from 16.00 hrs to 06,00 hrs on 09.09.18

(i) Cocoterie Road, Ste Croix from Cocoterie Round About up to junction with Nicolay Road and Ducray Street, Ste Croix;

(ii) Ducray Street from its junction with Nicolay Road to that with Pamplemousses Road; and

(iii) Pamplemousses Road from its junction with Ducray Street up to Vallee des Pretres Cross Road (Media Building); and

4. One-Way Street - on 09.09.2018 from 06.00 hrs to 18.00 hrs

Allée Père Laval from its junction with Pamplemousses Road up to Père Laval Church.

5. Diversion of Traffic on 08.09.18 as from 16.00 hrs to 06.00 hrs on 09.09.18

- (i) Vehicular traffic proceeding towards the North including motor buses on routine trips motoring along Royal Street will, when reaching junction Nicolay Road and Military Road, be diverted onto Military Road towards Quay "D" Round About onto the New Trunk Road to proceed to the North;
- (ii) Vehicular traffic coming from the North on Old Royal Road, Terre Rouge will, when reaching junction Pamplemousses Road and Riche Terre Road be diverted onto Riche Terre Road towards Riche Terre Round About to New Trunk Road to proceed to the South; and
- (iii) Buses on routine trips to the North will use New Trunk Road up to Terre Rouge Round About, then diverted onto Old Royal Road, Terre Rouge to disembark and embark passengers and back to New Trunk Road through Riche Terre Road to proceed to the North.

6. Route for Vehicular Traffic Motoring Along The New Trunk Road and Bound for Vallée des Prêtres & Plaine Verte.

On 08.09.18 as from 16.00 hrs to 06.00 hrs on 09.09.2018.

Vehicular traffic motoring along the New Trunk Road either from the North or from the South or from the direction of Tombeau Bay and proceeding either towards Vallée des Prêtres or Plaine Verte will, when reaching Quay "D" Round About be diverted onto Military Road, Pamplemousses street, Plaine Verte towards their respective destinations.

7. Route to Père Laval Church for Official Vehicles

Official vehicles motoring along the New Trunk Road and exhibiting a "PASS" and

proceeding towards Pere Laval Church will when reaching Cocoterie Round About be diverted onto Cocoterie Road via Ducray Street, Pamplemousses Road onto Piéton Pere Laval Ste Croix Road and Ste Marie Road.

8. Way Out for Official Vehicles from Père Laval Church

Official vehicles leaving Père Laval Church and proceeding towards Khadafi Square will do so along Ste Marie Road straight away up to Cité La Cure Bus Stand or via Sophia Lane and thereafter, exit along Bernardin de Saint Pierre Street and Vallée des Prêtres Cross Road.

9. Route for Vehicles proceeding towards Cité La Cure

Vehicles proceeding towards Cité La Cure will do so via Bernardin de St Pierre Street, Vallée des Prêtres.

10. Parking of Vehicles

Vehicles will be allowed to park on a reserved parking space at Cité La Cure Bus Stand, along the thoroughfares of Morcellement La Valine and in the yard of both St Gabriel College.

11. Prohibited Parking

Vehicles will not be allowed to park along the following thoroughfares: -

- (a) Pamplemousses Road from its junction with Riche Terre Road near Bazire Bridge, Ste Croix up to Vallée des Prêtres Cross Road;
- (b) Nicolay Road from its junction with Military Road up to Abercrombie Round About;
- (c) Cocoterie Road from its junction with Nicolay Road up to Cocoterie Round About;
- (d) Riche Terre Road from Trois Bras up to Riche Terre Round About;
- (e) Piéton Père Laval from its junction with Pamplemousses Road up to that with Ste Croix and Ste Marie Roads; and
- (f) Ste Marie Road from its junction with Ste Croix Road up to that with Sophia Lane.

12. Buses**(a) Disembarkation Point- on 08.09.18 as from 16.00 hrs to 06.00 hrs on 09.09.18**

- (i) Special Route buses as well as those from Port Louis on routine trips and bound for Pere Laval Church will disembark their passengers along Ducray Street, Ste Croix; and
- (ii) Buses from the Northern and Eastern part of the island and bound for Père Laval Church will disembark passengers at the bus stop near Dhanush Stone Crusher, Terre Rouge.

(b) Embarkation Point on 08.09.18 as from 16.00 hrs to 06.00 hrs on 09.09.18

- (i) Special route buses awaiting passengers will park on the left of the road along Military Road when facing British American Tobacco (BAT);
- (ii) Buses on routine trips will embark passengers as hereunder:-
 - At an improvised bus stop along Famplemousses Road, Ste Croix near Riche Terre Branch Road for passengers bound for the Northern and Eastern part of the Island; and
 - At the bus stop located along Pamplemousses Road, Ste Croix near Pyneeandee Shop (near junction of Ducray Street) for passengers bound for Port Louis and for the Southern part of the Island.

13. BUS STOP - On 08.09.18 as from 16.00 hrs to 06.00 hrs on 09.09.18

The bus stop along Nicolay Road adjacent to Abercrombie Police Married Quarters and that along Pamplemousses Road near Abercrombie Police Station and all other bus stops within the prohibited zone will not be operational as embarkation and disembarkation points for passengers.

14. TAXI STAND - Abercrombie

On 08.09.18 as from 16.00 hrs to 06.00 hrs on 09.09.18, the actual taxi stand at Ducray Street, Ste Croix will not be operational but instead will be Shifted along Cocoterie Road, Ste Croix.

15. On 09.09.2018 as from 0600 hrs to 1800 hrs - Route for Vehicular Traffic Motoring Along The New Trunk Road and Bound for Vallée des Prêtres and Plaine Verte.

- (i) Vehicular Traffic motoring along the New Trunk Road either from the North or from the South or from the direction of Tombeau Bay and proceeding either towards Vallée des Prêtres or Plaine Verte will, when reaching Cocoterie Round About be diverted onto Cocoterie Road - Nicolay Road - Abercrombie Round About - Pamplemousses Road towards their respective destinations.
- (ii) Vehicular Traffic including motor buses on routine trips motoring along Allée Pere laval street to Pere Laval Church will not be allowed to use the same road for their return journey and
- (iii) Vehicular Traffic coming from Cite La Cure will do so via Bernardin De St Pierre Street or Pieton Père Laval Street, Ste Croix to proceed to Khadafi Square and Immigration Bus Stand.

Non-compliance with these traffic arrangements will entail judicial proceedings.
