COMMENTS

The Bank posted a marked performance for the year under review despite the challenging operating context, on both the local and international fronts.

Operating income sustained its growth momentum, rising by 10.7% to reach Rs15,059 million. This contributed to a rise of 8.4% in profit for the year which stood at Rs6,762 million. The share of foreign-sourced earnings improved to 49% in line with our international diversification strategy.

Net interest income grew by 13.8% to Rs10,109 million on account of the sizeable growth in our international loan book and the increased investments in MUR Treasury Bills resulting from persistent excess liquidity levels.

Non-interest income rose by 4.8% to Rs4,950 million. The growth of 6.5% in net fee and commission income, reaching Rs2,777 million, was driven by cards and regional trade finance activities within the Energy & Commodities business. 'Other income' grew by 2.8% to reach Rs2,173 million on account of the marginal rise in the combined profit arising from dealing in foreign currencies and net loss from financial instruments carried at fair value.

Operating expenses increased by 8.6% to Rs5,455 million resulting from capacity building initiatives to support the Bank's strategic objectives. Major investment costs were incurred to align and upgrade human capital, technology and infrastructure and to execute the Bank's digital transformation initiative.

Our Cost to Income ratio fell from 36.9% to 36.2% over the period.

Impairment charges registered a growth of 29.3% to reach Rs1,229 million due to additional portfolio provision charges on the increased loan book. Impairment charges to total loans increased marginally to reach 0.59%.

Profit before tax improved by 9.8% to reach Rs8,374 million. Income tax expense increased by 15.9% despite a higher share of foreign sourced income. This resulted from a one-off charge of Rs258 million made for previous years, following an agreement reached with the MRA on the revised methodology for re-classification of deductible non-interest expenses.

The significant increase in on and off balance sheet customer exposures mainly resulted in a corresponding increase in our risk weighted assets. As a result, the Bank noted a fall in both Total and Tier 1 Capital Adequacy ratios as at 30 June 2018 which reached 15.0% and 14.2% respectively, still within a comfortable margin above the current regulatory requirements.

Going forward, the Bank will continue to execute its key strategic business development initiatives, with judicious diversification into new products and markets, whilst building internal capabilities to sustain growth. Better results are also expected as the Bank will benefit from the full impact of the loans portfolio growth which occurred in the latter part of the financial year.
