By virtue of authority conferred upon me by Section 25(3) of the Police Act and 181(1)(2) & (3) of the Road Traffic Act, the traffic arrangements as hereunder will be made on **01<sup>st</sup> November, 2018** and **02<sup>nd</sup> November, 2018 from 06.00 hours to 18.00 hours** respectively in connection with above event.

**2. One Way Street**

The following Streets will carry traffic only in the direction mentioned below:–

- (a) Nelson Street - One Way from the direction of Cemetery towards Reserves Street.
- (b) Cemetery Road - One Way from the direction of Cassis Road towards Les Salines Garden (the sea).
- (c) Ruthworth Street - One Way from the junction with Cemetery Road towards Reserves Street.
- (d) Douglas Street -One Way from the junction with Cemetery Road towards Reserves Street.
- (e) Abercrombie Street - One Way from the direction of Bouloux Centre towards Ruthworth Street.
- (f) Stevenson Street - One Way from the direction of Bouloux Centre towards Bain des Dames Road.
- (g) Dundonald Street - One Way from the direction of Ruthworth Street towards Nelson Street.
- (h) Malborough Street - One Way from the direction of Cemetery Road towards Nelson Street.

**3. Judicial Proceedings**

Non compliance with these traffic arrangements will entail judicial proceedings.
