Members of the public are hereby informed that pursuant to the Civil Aviation (Amendment) Regulations 2016 (GN 139 of 2016), it is strictly prohibited to fly or operate Remotely Piloted Aircraft (Drones) over an organised open-air assembly of more than 500 persons except in accordance with a permission granted by the Civil Aviation Department.

2. In connection with Papal Visit scheduled on 09 September 2019, no person shall fly/operate Remotely Piloted Aircraft (Drones) over Marie Reine de la Paix, Monseigneur Leen St, Cathédrale Saint Louis, Dauphine St, Shrine of Father Laval, Allée Père Laval, Saint Croix, State House, Réduit or within a perimeter of 2 kms thereof.

3. The above measure is aimed at ensuring the safety and security of VVIPs, VIPs, dignitaries and members of the public who will converge thereat for prayers and other activities.

4. The flying or operating of Remotely Piloted Aircraft (Drones) in the above mentioned areas without the permission of the Director of Civil Aviation would constitute an offence under the Civil Aviation Regulations 2007 (as amended by GN 139 of 2016), for which the offender may be liable to a fine not exceeding Rs 10,000/- and to imprisonment for a term not exceeding twelve months.


