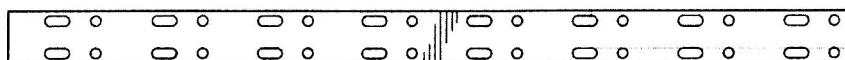
Representation of Design:



Three-dimensional view

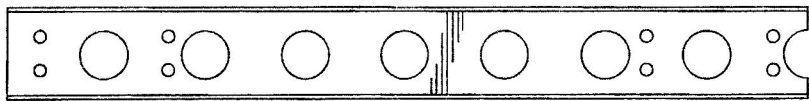


Top view

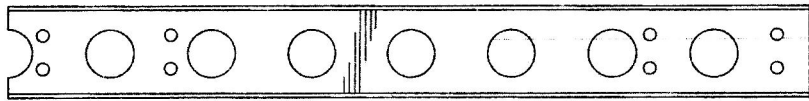

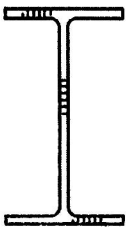

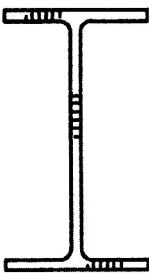
Side view
