- (i) the 22nd day of October 2019: day of election (nomination day);
- (ii) the 7th day of November, 2019: polling day, if it becomes necessary to adjourn the election for the taking of a poll.

THE NATIONAL ASSEMBLY ELECTIONS REGULATIONS 2014

[Regulations 2 and 5(1)]

NOTICE OF ELECTION OF SIXTY TWO MEMBERS OF THE NATIONAL ASSEMBLY

The President of the Republic having issued writs for the election of three Members of the National Assembly for each of the twenty constituencies of Mauritius, and of two Members for the Constituency of Rodrigues, the returning officer for each constituency will, on Tuesday the twenty-second (22nd) day of October, 2019 next ensuing, between the hours of 9 a.m. and 3 p.m. at the "Nomination Centre" respectively shown opposite each constituency in the schedule below, receive the nomination of candidates for election as Members of the National Assembly for each constituency and if there is no opposition, proceed to the election of three Members for each of the twenty constituencies of Mauritius and of two Members for the Constituency of Rodrigues.

Forms of nomination paper may be obtained at the Office of the Electoral Commissioner, MaxCity Building, Corner Remy Ollier and Louis Pasteur Streets, Port Louis or at the sub-office of the Electoral Commissioner at Port Mathurin, Rodrigues between the hours of 9 a.m. and 3 p.m. on working days, except on Saturdays when the office will be closed at noon. The forms can also be downloaded at the website of the Office of the Electoral Commissioner at <http://electoral.govmu.org>.

Every nomination paper shall be signed by at least 4 registered electors of the constituency in which the candidate seeks election, be accompanied by the National Identity Card of the candidate or his passport, driving licence or bus pass, and be submitted to the returning officer between the hours of 9 a.m. and 3 p.m.

Where a nomination paper is submitted by a person acting on behalf of a candidate, it shall be accompanied by the National Identity Card of that person and that of the candidate, or such other proof of identity, as mentioned above.

Every nomination paper shall specify the name, sex, address and occupation of the candidate and contain a declaration by the candidate that he is qualified.

A deposit of 1,500 rupees shall be made upon the submission of the nomination paper.

Each candidate belonging to a party or party alliance shall make and subscribe on his nomination paper –

- (a) a declaration of the party or party alliance, if any, registered under regulation 8 of the National Assembly Elections Regulations 2014, to which he belongs, and he shall submit a certificate from his party or party alliance certifying that he belongs to that party or party alliance;
- (b) a declaration as to which of the Hindu, Muslim, Sino-Mauritian or General Population community he belongs to.
