Notice is hereby given that I have decided to acquire compulsorily on behalf of the State of Mauritius a portion of land situate at Palma in the district of Plaines Wilhems for the **public purpose of Upgrading of Palma Roundabout**.

- (b) Vehicles from the direction of Highlands and Hermitage attending the function, will alight their passengers near Highlands Sugar Estate.

5. Parking Of Vehicles

- (a) Vehicles of VVIPs/VIPs with "Gold and Red Parking Cards" will have access through the main gate No. 1 and park inside the premises of Aleemiah College.
- (b) Vehicles of Staff with "Pink Parking cards" will park, perpendicular to Main Entrance.
- (c) Vehicles of members with "Green Parking Cards" will be parked inside the Dar-UI-Uloom yard.
- (d) Vehicles of the MBC Crew will park at the VVIP parking and will have access to college yard through gate No. 2.
- (e) Special Route Buses will be parked in the yard of Highlands Sugar Estate.
