DELEGATION OF POWERS FOR THE CANCELLATION OF PERMITS REGARDING NON-CITIZEN WORKERS

In accordance with section 4(5) of the Non-Citizens (Employment Restriction) Act, the Minister responsible for the subject of employment may, in writing, cancel a permit which had been issued to a non-citizen for engaging in an employment or occupation in Mauritius.

Notice is hereby given that as from the date of this publication, the Minister of Labour, Human Resource Development and Training has delegated his powers for the cancellation of permits to the Permanent Secretary of the Ministry of Labour, Human Resource Development and Training (Human Resource Development and Training Division).
