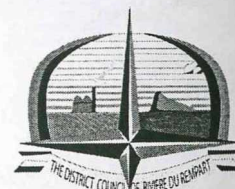

By virtue of authority conferred upon me under Section 25 (3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made on 23<sup>rd</sup> August, 2020 in connection with the above ceremony.

**WESTERN DIVISION****QUATRE BORNES AND BAMBOUS DIVISIONS**

(Immersion Ceremony at Pierrefonds River Spiritual Park)

**2. NO PARKING ZONE AS FROM 0700 HRS UNTIL THE CEREMONY IS OVER**

- (i) No vehicles will be allowed to park within Pierrefonds Roundabout on both sides of the road proceeding towards Beau Songes and also along the road leading to the river bank;
- (ii) No vehicles will be allowed to park on both sides of Phoenix/Beau Songes Link Road when facing Solferino; and,
- (iii) No vehicles will be allowed to park on both sides of Palma Road between Palma SSS & Pierrefonds Roundabout.

**Note:** Hawkers will not be allowed to operate near the vicinity and the immediate area of the Spiritual Park.

**3. PARKING ZONE AS FROM 0700 HRS UNTIL THE CEREMONY IS OVER**

No vehicles will be allowed to enter or park along Seegoolam Lane on both sides of the road leading to Shiv Sagar Mandir.

**6. PARKING ZONE**

All vehicles coming for the immersion ceremony will be parked at the parking space near Nenuphar Complex and its vicinity and other side roads in Morcellement Bismic and Morcellement Chazal.

- (ii) Bain des Dames Public Beach (except VIP and Organizers);
- (iii) Cassis Road from its junction with Edouard Street to that of Menagerie Street; and,
- (iv) Menagerie Street from its junction with Cassis Road to that of Saint Joseph Street.

#### **11. PARKING ZONE**

- (i) Stevenson Street from its junction with Edouard Street to Gibraltar Street on the left hand side;
- (ii) Charron Street on the left hand side facing Stevenson Street;
- (iii) Edouard Street on the left hand side facing Cassis Road;
- (iv) Cassis Road from its junction with Gibraltar Street to that of Bain Des Dames Street (left hand side);
- (v) Green space of Freddy Desveaux Stadium and close vicinity; and,



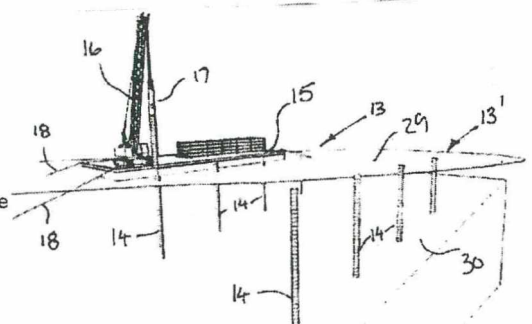
