POLICE NOTICE

PUBLIC PROCESSION

By virtue of authority conferred upon me by Section 25(3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements, as hereunder, will be made in Port-Louis, on Saturday 29th August, 2020 respecting a public procession. The public shall strictly comply with these arrangements unless otherwise directed by Police.

2. Closed Streets for Vehicular Traffic (as from 1200 hrs)

- Pope Hennessy Street from its junction with Labourdonnais Street up to that with Dauphine Street;
- b) Jules Koenig Street;
- c) Intendance Street;
- d) Queen Elizabeth Avenue;
- e) Suffren Street from its junction with Mgr Gonin Street up to that with Pope Hennessy Street;
- f) Church Street from its junction with GMD Atchia Street up to that with Lislet Geoffroy Street;
- g) Lislet Geoffroy Street from its junction with Poudrière Street up to that with Pope Hennessy Street;
- h) Lislet Geoffroy Street from its junction with Mgr Gonin Street up to that with Pope Hennessy Street (except for route buses);
- Dauphine Street from its junction with Pope Hennessy Street to that with Mgr Gonin Street;
- j) Sir Virgil Naz Street from its junction with Eugene Laurent Street up to that with Jules Koenig Street;
- k) SSR Street from its junction with Mgr Gonin Street up to that with Jules Koenig Street;

- 1) Sir William Newton Street from its junction with Remy Ollier Street up to that with Dauphine Street;
- m) Maillard Street from its junction with Poudrière Street up to that with Jules Koenig Street;
- n) Queen Street from its junction with Bourbon Street up to that with Duke of Edinburgh Street;
- o) Reverend Lebrun Street from its junction with Brown Sequard Street up to that with John Kennedy Street;
- p) Sir Celicourt Antelme Street from its junction with Brown Sequard Street up to that with John Kennedy Street;
- q) Lord Kitchener Street from its junction with Jemmapes Street up to that with Edith Cavell Street;
- r) Ferguson Street from Place Bissoondoyal to its junction with Royal Street;
- s) Chaussée Street from its junction with Queen Elizabeth Avenue to that with Edith Cavell Street;
- t) Edith Cavell Street from its junction with Chaussée Street to that with John Kennedy Street;
- u) John Kennedy Street from its junction with Edith Cavell Street to that with Oueen Elizabeth Avenue; and,
- v) Dr Ferrière Street.

3. Traffic Diversion (as from 1200 hrs)

- (i) Vehicular traffic coming from the direction of Labourdonnais Street on reaching junction with Pope Hennessy Street will be diverted onto Frère Félix de Valois Street, G.M.D Atchia Street and Eugene Laurent Street;
- (ii) Vehicular traffic coming from the direction of Plaine Verte along SSR Street and proceeding towards Champ de Mars will be diverted onto Mgr Gonin and D'Estaing streets;

- (iii) Vehicular traffic coming from the direction of Plaine Verte along SSR Street and proceeding towards Place D'Armes will be diverted onto Corderie Street;
 - (iv) Vehicular traffic along Queen Street will be diverted onto Bourbon Street;
 - (v) Vehicles motoring along the motorway from the North proceeding towards the City Centre will be diverted to Caudan Roundabout, Maupin Street and A1 Road;
- (vi) Vehicles motoring along the motorway from the South will be diverted onto Louis Pasteur Street; and,
 - (vii) Vehicles coming from Bell Village proceeding towards the City Centre will be diverted onto Jemmapes Street.

4. Route Buses (as from 1200 hrs)

- (i) Buses motoring from Labourdonnais Street proceeding towards Plaine Verte or Immigration Square will be diverted onto D'Estaing and Eugene Laurent Streets and proceed to their respective destinations;
- (ii) Buses coming from the direction of Plaine Verte along SSR Street and proceeding towards Cite Vallijee will be diverted along Mgr Gonin Street, Lislet Geoffroy Street and Pope Hennessy Street;
- (iii) Buses coming from the direction of Bell Village and proceeding towards Immigration Square Bus Stand will be diverted onto Deschartres Street, Caudan Roundabout, Kwan Tee Street, Reserve Street, Motorway M1, Immigration Square and then to their respective bus stands; and,
- (iv) Buses coming from the direction of Bell Village and proceeding towards
 Dumas Street and John Kennedy
 Street will be diverted into Jemmapes
 Street where they will alight their passengers and then proceed along

Orleans Street, Deschartres Street, Caudan Roundabout, Kwan Tee Street, Reserve Street, Motorway M1, Post Office Lane, turn right into Motorway M1 Southbound to their respective bus stands.

5. No Parking Zone (as from 0700 hrs)

- (i) Mgr Gonin Street from SSR Street to D'Estaing Street;
- (ii) G.M.D. Atchia Street from Pope Hennessy Street to Eugene Laurent Street;
- (iii) Dauphine Street from Pope Hennessy Street to Mgr Gonin Street;
- (iv) Dr Ferriere Street;
- (v) Chaussée Street;
- (vi) Pope Hennessy Street;
- (vii) Jules Koenig Street;
- (viii) Intendance Street; and,
- (ix) EdithCavell Street as from its junction with Chaussée Street to that with John Kennedy Street.

6. Judicial Proceedings

- (i) Non compliance with these traffic arrangements will entail judicial proceedings.
- (ii) The cooperation and understanding of the public will be much appreciated.

POLICE NOTICE

YAMSEE FESTIVAL 2020

By virtue of authority conferred upon me by Section 25(3) of the Police Act and Section 181

of the Road Traffic Act, traffic arrangements as hereunder will be made in connection with the Yamsee Festival 2020 styled "RATIFFS" in Plaine Verte division on Friday 28th August, 2020 as from 1730 hrs until the ceremony is over.

2. Routes of Processionists

The processionists from each Congregation will start at Khadafi Square, Plaine Verte proceeding along Pamplemousses Street via Dr Hassen Sakir Street – Ail Doré Street – Hassen Hussein Street – Paul et Virginie Street and Trichinapoly Street to reach their respective "Dargas".

3. Closed Streets

On the occasion of the festival, the following streets will be closed to vehicular traffic as from 1730 hrs until all the Congregations have left Khadafi Square, Plaine Verte: –

- (i) Pamplemousses Street from Khadafi Square to Dr Hassen Sakir Street, Plaine Verte;
- (ii) Pamplemouses Street from Dog Pound up to Dr Hassen Sakir Street, Plaine Verte;
- (iii) Dr Hassen Sakir Street from its junction with Pamplemousses Street to Paul et Virginie Street, Plaine Verte; and,
- (iv) Madad Ul Islam Street from its junction with St Francois Xavier Street to Pamplemousses Street, Plaine Verte.

4. Diversion of Traffic

- (i) Buses coming from the North along Pamplemousses Road proceeding towards the South and Immigration Bus Stand will be diverted at Abercrombie Round About into Nicolay Road via Noor E Islam street onto Mariammen Temple street to Immigration Bus Stand.
- (ii) Buses coming from Vallée des Prêtres along Bernardin de St Pierre Street proceeding towards the South and Immigration Bus Stand will be diverted at Corner Pamplemousses and Military Roads into St Francois Xavier Street

- via Nicolay Road Noor E Islam Street onto Mariammen Temple Street to Immigration Bus Stand;
 - (iii) Buses coming from Plaine Verte Bus Stand along Madad Ul Islam Street proceeding towards the South and Vallee Pitot will be diverted at Corner St Francois Xavier and Madad Ul Islam Streets into SSR Street via La Paix Street; and,
- (iv) Vehicular traffic coming from the North and Vallee des Pretres along Pamplemousses Streets proceeding towards the South will be diverted into side roads.

5. Bus Stops

All Bus Stops along Pamplemousses Street, Plaine Verte will not be operational for the embarkation and disembarkation of passengers on that day as from 1730 hrs.

6. No Parking Zone

Dr Hassen Sakir Street (Ex Pagoda) from its junction with Pamplemousses Road up to Paul and Virginie Street will be a no parking zone as from 1600 hrs.

7. Music

The processions will be accompanied by music. Styled "RATIFFS" will be allowed only to those forming part of the "Ghoons". Music will cease and silence observed whenever any of these processions come across any place of worship or as so ordered by Police.

8. Interference with Processionists

No person shall unnecessarily interfere with or cause any annoyance to any person participating in the processions.

9. Judicial Proceedings

Non compliance with these regulations may entail judicial proceedings.

POLICE NOTICE

YAMSEE FESTIVAL 2020 STYLED "CASSEE DU GHOON"

By virtue of authority conferred upon me by Section 25(3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made in connection with the Yamsee Festival 2020 styled "CASSEE DU GHOON" in Plaine Verte and Abercrombie divisions on Sunday 30th August, 2020 as from 1500 hrs to 2200 hrs.

2. Routes of Processionists

The processionists from each Congregation will start at Dr Hassen Sakir Street (ex Pagoda Street), Plaine Verte proceeding along Pamplemousses Street via La Croisee Vallee des Pretres to Karbala at Vallee des Pretres.

3. Closed Streets

On the occasion of the "CASSEE DU GHOON" the following streets will be closed to vehicular traffic as from 1500 hrs until all the procession is over:—

- (i) Abercrombie Roundabout up to La Croisee Vallee des Pretres;
- (ii) Sophia Lane with its junction with Bernardin de St Pierre to La Croisee Vallee des Pretres;
- (iii) Military Road from its junction with St Francois Xavier up to Pamplemousses Streets;
- (iv) Pamplemousses Road from La Croisee Vallee des Pretres up to Magon Street and all laterals roads:

- (v) Dr Hassen Sakir Street (ex Pagoda Street) from its junction with Pamplemousses Street to Paul et Virginie Street, Plaine Verte;
- (vi) Cite Laval Street from its junction with St Francois Xavier Street up to Pamplemousses Road; and,
- (vii) Madras Street from its junction with Pamplemousses up to St Francois Xavier Streets.

4. Diversion of Traffic

- (i) Buses coming from the North along Pamplemousses Road proceeding towards the South and Immigration Bus Stand will be diverted at Abercrombie Roundabout into Nicolay Road via Noor E Islam Street onto Mariammen Temple Street to Immigration Bus Stand; and,
- (ii) Buses coming from Vallee des Pretres along
 Bernardin de St Pierre Street proceeding
 towards the South and Immigration Bus
 Stand will be diverted at Sophia Lane Le
 Cornu Ste Croix Road Allee Pere Laval
 Abercrombie Roundabout Nicolay Road
 Noor E Islam Street onto Mariammen
 Temple Street to Immigration Bus Stand.

5. Bus Stops

All Bus Stops along Pamplemousses Street, Plaine Verte will not be operational for the embarkation and disembarkation of passengers on that day as from 1500 hrs.

6. No Parking Zone as from 1400 Hrs

- (i) Dr Hassen Sakir Street (Ex Pagoda) from its junction with Pamplemousses Road up to Paul and Virginie Street will be a *no parking zone* as from 1400 hrs; and,
- (ii) Pamplemousses Road from La Croisee Vallee des Pretres up to Magon Street.

7. Music

The processions will be accompanied by music. Styled "CASSEE DU GHOON" will be allowed only to those forming part of the "GHOON". Music will cease and silence observed whenever any of these processions come across any place of Worship or as so ordered by Police.

8. Interference with Processionists

No person shall unnecessarily interfere with or cause any annoyance to any person participating in the processions.

9. Judicial Proceedings

Non compliance with these regulations may entail judicial proceeding.
