#### POLICE NOTICE

#### **REMEMBRANCE DAY 2020**

By virtue of authority conferred upon me by Section 25 (3) of the Police Act and Section 181 (1) (2) and (3) of the Road Traffic Act, traffic arrangements as hereunder will be made on Thursday 5 November 2020 at 1000 hrs in connection with a dress rehearsal in front of War Memorial, Curepipe.

#### 2. CLOSED STREETS

The stretch of the road from junction Chasteauneuf and Royal Road and junction Malartic and Royal Road will be closed to vehicular traffic.

# 3. DIVERSION OF TRAFFIC

Traffic will be diverted as follows:-

- (a) Vehicular traffic from the south proceeding towards Eau Coulee along Royal Road will be diverted to Commerford Street;
- (b) Vehicular traffic from Eau Coulee proceeding towards Curepipe will be diverted to Malartic and Pope Henessy Streets; and,
- (c) Vehicular traffic coming from Les Casernes will be diverted onto Chasteauneuf Street.

#### 4. JUDICIAL PROCEEDINGS

Non compliance with these traffic arrangements will entail judicial proceedings.
